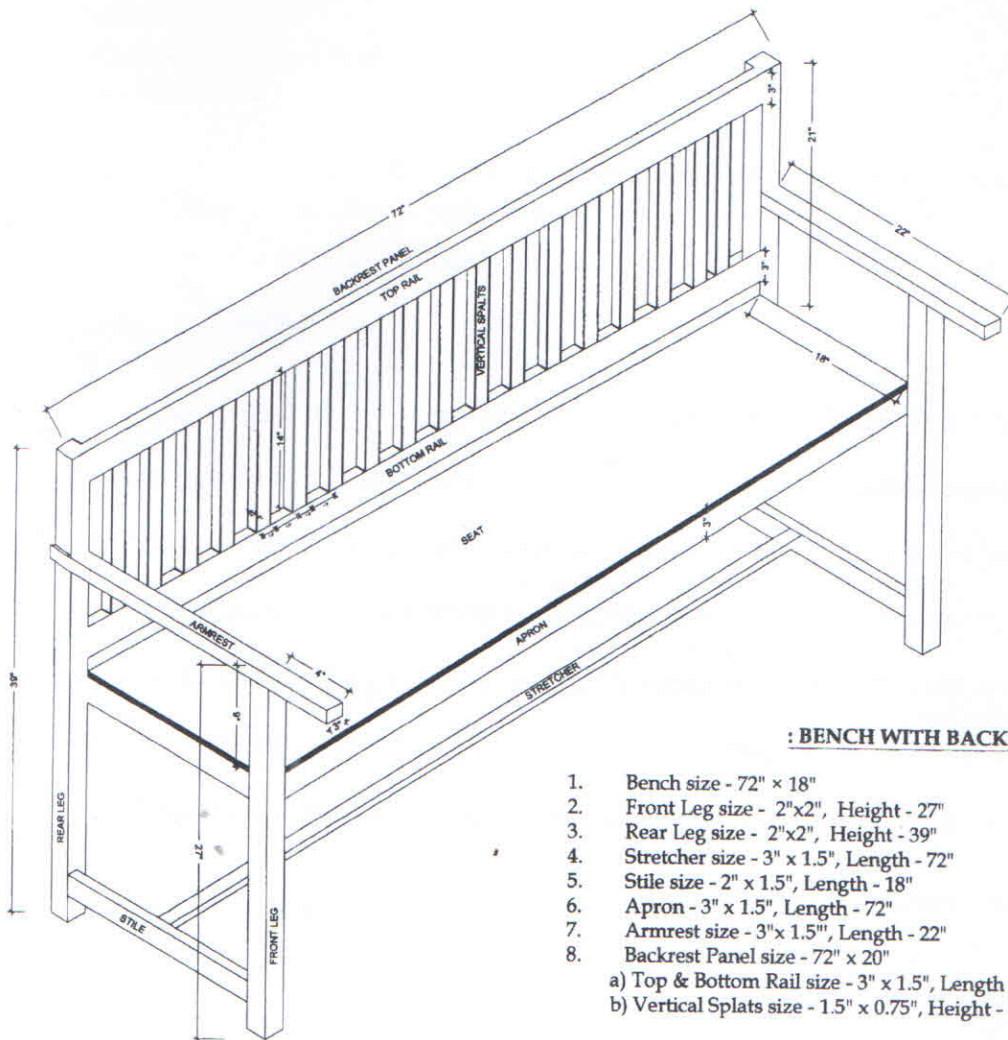

 6. Apron - 3" x 1.5", Length - 72"
 7. Armrest size - 3" x 1.5", Length - 22"
 8. Backrest Panel size - 72" x 20"
- a) Top & Bottom Rail size - 3" x 1.5", Length - 72"
