# MINUTES OF THE MEETING OF THE 'BOARD OF CONTROL FOR TRAINING' HELD ON 12.05.2020 IN THE MATTER OF QUALIFICATION OF FIRST PHASE OF 1230 RCs IN THE FIRST PHASE TO BE PASSED OUT ON 15.05.2020

- 1. To examine the Result Sheet of the Final Examination of 1230 Recruit Constables of Batch No. 216/2019-20 of different STCs.
- ii) DIG, Training/Principal, SVSPA, WB, Barrackpore shared the Result Sheet of the Final Examination of RCs Batch No. 216/2019-20 vide memo. no. SVSPA/Exam.Cell/RC/11(VII)/2017-2025 dtd. 12.05.2020.
- iii) A total of 2457-Recruit Constables joined to undergo training at STC EFR  $2^{nd}$  Bn., PTS Salua, STC SAP  $12^{th}$  Bn., and STC SAP  $9^{th}$  Bn., Sandhya.
- iv) Out of 2457- Recruit Constables, 1210-Recruit Constables are engaged for Law & Order duty in different districts & Commissionerates as per Order of PD, WB.
- v) During the course of **1**<sup>st</sup> **Phase** training at different training Units **16**-Recruit Constables tendered their resignations from service and those were accepted by the Controlling Authorities.
- vi) 01 (one) Recruit Constable remained away from training for more than 25% of the training period and he has been reverted to the next batch.
- vii) A total of 1230 Recruit Constables appeared in the final examinations (Statement & List enclosed)
- viii) 1229 Recruit Constables have completely passed in all the indoor and outdoor subjects.
- ix) 01 RC of PTS, Salua did not appear in the indoor final examinations though he cleared all the Outdoor Examinations.

The result of the same is shared with the members of the 'Board of Control for Training' for approval.

## The Board unanimously resolved the following decision:

- The Board approved the overall result of 1230-Recruit Constables of different STCs of which 1229 have completely passed in the both indoor and outdoor subjects.
- > 01 (one) Recruit Constable/1407 namely Masud Jaman Mallick of PTS Salua who remained away from training for more than 25% of training duration, will be reverted to the next batch. He will attend his basic training along with the next batch to be started shortly. DIGP, Training/Principal, SVSPA, Barrackpore will inform the concerned unit for basic training of batch reverted RC.

➤ Board also resolved that, 01 (one) Recruit Constables/1704 namely Somnath Mukherjee of PTS Salua, who did not appear in different indoor examinations, will also be detained for that period so that he can appear in the Indoor Examinations along with next phase trainees after the date of passing out parade. DIGP, Training/Principal, SVSPA, Barrackpore will arrange for his supplementary examinations. As he appeared in Outdoor Examinations & qualified successfully, this will go to his credit & he does not require appearing in Outdoor Examinations again.
