## MINUTES OF THE MEETING OF THE 'BOARD OF CONTROL FOR TRAINING' HELD ON 27.05.2020 IN THE MATTER OF QUALIFICATION OF SECOND PHASE OF 1227 RCs & LRCs IN THE SECOND PHASE TO BE PASSED OUT ON 29.05.2020

- 1. To examine the Result Sheet of the Final Examination of 1227 Recruit Constables of Batch No. 217/2019-20 of different STCs.
  - i) DIG, Training/Principal, SVSPA, WB, Barrackpore shared the Result Sheet of the Final Examination of RCs Batch No. 217/2019-20 vide memo. no. SVSPA/Exam.Cell/RC/11(VIII)/2017-12 dtd. 20.05.2020.
  - ii) A total of 2583 (2554-Recruit Constables and 29-Lady Recruit Constables) joined to undergo training at STC 4th Bn., TTC 13th Bn., TTC 15th Bn., TTC 10th Bn., TTC 11th Bn., and SVSPA, WB.
  - iii) Out of 2583-Recruit Constables, 1329-Recruit Constables are engaged in Law & Order duty in different districts & Commissionerates as per Order of PD, WB.
  - iv) During the course of 2<sup>nd</sup> Phase training at different training Units 13-Recruit Constables tendered their resignations from service and those were accepted by the Controlling Authorities.
  - v) A total of 14 (10-Recruit Constables and 04-Lady Recruit Constables) remained away from training for more than 25% of the training period and they have been reverted to the next batch.
  - vi) A total of 1227 (1202-Recruit Constables and 25-Lady Recruit Constables) appeared in the final examinations (Statement & List enclosed)
  - vii) A total of 1227 (1202-Recruit Constables and 25-Lady Recruit Constables) completely passed in all the indoor and outdoor subjects.

The result of the same is shared with the members of the 'Board of Control for Training' for approval.

## Background of the decision of Four Phases of Pass-out:-

In a meeting held on 28.04.2020 at Nabanna Conference Hall, attended by respected DG&IGP, WB, DG&IGP(A), WB, ADG, Training, WB, ADG (L&O), WB, DIG (A), WB, DIG/Principal, SVSPA & others, it was unanimously decided that the RCs / LRCs who were undergoing their Basic Training at 12 different STCs / PTS / SVSPA would be passed out in four Phases. On 15.05.2020, already 1229 RCs passed out as being the first Phase. Passing-out of 1227 RCs / LRCs is the second Phase. Two more Phases are on the cards as per decision taken in the meeting on 28th April, 2020. Tentatively the dates were fixed on 12.06.2020 & 17.07.2020 though there are many other parameters that may factor in selecting the dates such as Quarantine of Trainees, staggered joining time of RCs from duty, etc.

## The Board unanimously took the following decision:-

- ➤ The Board approved the overall result of 1227 (1202-Recruit Constables and 25-Lady Recruit Constables) of different STC, TTCs & SVSPA who have completely passed in the both indoor and outdoor subjects.
- ▶ 14 (10-Recruit Constables and 04-Lady Recruit Constables) of different training Units who remained away from training for more than 25% of training duration on different grounds, will be reverted to the next batch (4th phase). They will attend their basic training along with the next batch to be started shortly. DIGP, Training/Principal, SVSPA, Barrackpore will inform the concerned units for basic training of batch reverted RCs.
