**MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND**  
**PROMOTION HELD ON 12<sup>th</sup> May 2021.**

A meeting of the Board of Control for Examination and Promotion was held on 12<sup>TH</sup> May, 2021 at 12.00 hrs. in the DGP'S Conference Hall, at Bhabani Bhawan, Kolkata-27.

The following points were discussed in the meeting of BOC for Examination & Promotion.

**(1) Length-cum-Record of Service Book of 01 (One) ASI (Armed Branch) for promotion to the rank of SI (Armed Branch) :-**

A Petition was submitted by the ASI(AB)1087 Sonjay Ghosh of Krishnagar PD vide SP, Krishnagar PD, memo no- 125/RO, Dated: 03-03-2021 stated that some ASIs(AB) who were junior to him have been promoted to the rank of SI(AB).

During Scrutiny of the record of Range Board, Screening Committee and earlier B.O.C, it was found that the date of officiation of ASI(AB) 1087 Sonjay Ghosh is 17-02-2011.

Later on Reserve Officer, Krishnagar PD were called to the office of the DIG (HQs), WB, along with original service book of ASI(AB)1087 Sonjay Ghosh of Krishnagar PD.

Upon scrutiny it was found that the date of officiation as per D.O is 11-02-2011 but two (02) dates i.e 17-02-2011 and 11-02-2011 have been mentioned in the service book.

After that SP, Krishnagar PD was requested to look into this matter and conduct a fresh Range Board and send the service particulars of the incumbent correctly to the office of the DIG (HQs) WB.

Accordingly DIG (Murshidabad Range) held a fresh Range Board of the said ASI(AB) and sent to the office of the DIG (HQs) WB, Vide memo no: 276/CI/RHQ, Dated: 11-04-2021.

After receiving the service particulars & the reports of Range Board in c/w ASI(AB) 1087 Sonjay Ghosh of Krishnagar PD, a meeting of the B.O.C, for Examination and Promotion was called to review the matter of the said ASI(AB).

### **Decision: -**
