Sub : Apportionment of sanctioned strength of Home Guard Volunteers to Jhargram District from the existing sanctioned strength of Bankura District.

The augmentation of sanctioned strength of Home Guard Volunteers in deferent district of West Bengal was made in terms of this Department Notification No. 180-PL/PB/14M-163/2018(Pt-I), dated 22.01.2021.

It has now become expedient to enroll 80(eighty) Home Guard Volunteers under Special Dispensation and train them properly for deployment in the district of Jhargram where the existing vacancy is Nil against sanctioned strength of 660 only. Whereas the vacancy position of Home Guard Volunteers in Bankura district is 331 against sanctioned strength of 900 only.

2) In order to meet the present need, after careful consideration of the matter, the Governor is pleased to make augmentation by way of apportionment of sanctioned strength of Home Guard Volunteers between Jhargram District and Bankura district in the Following manner.

Jhargram District has a sanctioned strength of 660 Home Guard Volunteers only. The said strength will be raised to 740 by apportionment of 80 Home Guard Volunteers from Bankura District and thereby reducing the sanctioned strength of Bankura district to 820 only.
