Roy Advocate High Court including the web Copy of the order dtd - 08.10.2021 passed by the Hon'ble 1<sup>st</sup> Bench of the Hon'ble WBAT in O.A No. 670 of 2021 in the matter of Niranjana Roy v/s the state of West Bengal and others informed by the

office of the SP, Paschim Medinipur vide his office memo no.-2699/RO dtd-28.11.2021.

Matter was placed before BOC for examination and promotion for decision.
