Sub.: Creation of 27 (twenty seven) regular posts in different categories under West Bengal Police and engagement of 01 (one) Karmabandhu on part-time basis for Bhorer Alo Police Station at Gajaldoba under Siliguri Police Commissionerate.

- 1) In terms of this Department's Notification No. 949-PL/PB/4P-09/19 dated 17.04.2023. Notification No. 950-PL/PB/4P-09/19, dated 17.04.2023 and Notification No. 951-PL/PB/4P-09/19 dated 17.04.2023. New Jalpaiguri Police Station, Bhaktinagar Police Station and Bhorer Alo Police Station have been created by way of bifurcation of the existing New Jalpaiguri Police Station and Bhaktinagar Police Station under Siliguri Police Commissionerate.
- 2) Now, the undersigned is directed to say that the Governor has been pleased to accord sanction to the creation of 27 (twenty seven) regular posts in different categories under West Bengal Police on the usual rate of pay and allowances and engagement of 01 (one) Karmabandhu on part-time basis for manning the New Bhorer Alo Police Station as detailed hereunder:-
 - (i) Sub-Inspector 02
 - (ii) Lady Sub-Inspector 01
 - (iii) Assistant Sub-Inspector 02
 - (iv) Lady Assistant Sub-Inspector 01
 - (v) Constable 15
 - (vi) Lady Constable 03
 - (vii) Police Driver 02 (filling up to be made on contractual basis)
 - (viii) Wireless Operator 01

- 3) 01 (One) Karmabandhu on part-time basis may be engaged at a consolidated remuneration of Rs. 3000/per month to be paid out of Contingency.
- 4) Filling up the required posts must be on observance of extant recruitment rules.
- 5) The charge is debitable to the appropriate Head of Account in the State Police Budget.
- 6) The order issues with the concurrence of the Finance Department vide their U.O. No. Group P2/2022-2023/0855 dated 15.02.2023. This has also been approved by the Cabinet held on 27.03.2023.
- 7) The Principal Accountant General (A & E), West Bengal is being informed.

MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 08.11.2023

A meeting of the Board of Control for Examination and Promotion was held on 08.11.2023 at 12:00 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

The following points were discussed in the meeting of BOC for Examination & Promotion.

 To examine Length-Cum-Record of Service of 09(nine) Supervisor (Technical) Grade-II for promotion to the rank of Supervisor (Technical) Grade-I in West Bengal Police Telecommunication Branch.

ADG & IGP, Telecommunication, WB, has sent memo no.- 410/RO dated 04.10.2023, containing the L-C-R-S for promotion of Supervisor (Technical) Grade-II to the rank of Supervisor (Technical) Grade-I of Telecom (HQ), WB.

- > The Range Board for promotion of eligible 09 (nine) Supervisor (Technical) Grade-II was held on 04.10.2023 at Telecom(HQ), WB, for promotion to the rank of Supervisor (Technical) Grade-I, of Telecom (HQ), WB and all 09(nine) were declared provisionally "fit" for promotion to the next higher rank.
- ➤ At present, there is 12(twelve) vacancies in the rank of Supervisor (Technical) Grade-I, of Telecom (HQ), WB.
- ➤ The L-C-R-S has been placed before the 'Board of control for Examination and Promotion' for perusal and approval.

<u>DECISION:</u> The Board examined the L-C-R-S and approved of the same for next course of action. Therefore, 09 (nine) Supervisor (Technical) Grade-II are provisionally 'fit' for promotion to the rank of Supervisor (Technical) Grade-I of Telecom(HQ), WB.
