MINUTES OF THE MEETING OF BOC FOR TRAINING HELD ON 01.02.2024 AT 12:00 HRS. AT THE OFFICE CHAMBER OF ADGP & IGP, TRAINING, WB, SALT LAKE, KOLKATA.

Smt. Damayanti Sen, IPS, Additional Director General & Inspector General of Police, Training, West Bengal presided over the meeting.

Following points were submitted for the discussion and decision thereupon by the Board:

- 1. Approval of result of the Final Examination of the Wireless Operator of Batch No. 25/2023:-
 - ➤ Total 997 trainees i.e. 338 at SVSPA, WB, Barrackpore, 386 Trainees at KPTA, 174 trainees at STC SAP 13th Bn., and 99 Trainees at STC SAP 4th Bn., Kasba reported for the training. Out of 997 trainees, 06 trainees of SVSPA, 07 trainees of KPTA, 06 trainees of STC SAP 13th Bn., and 01 trainee of STC SAP 4th Bn., total 20 trainees resigned from the service.
 - ➤ Total 12 trainees (at KPTA) have failed in Swimming Examination i.e. Outdoor subject. They will appear in supplementary examination after completion of technical training and special module for swimming training will be arranged for them at SVSPA.
 - ➤ Out of 997 Wireless operators, 965 have successfully passed both in indoor and outdoor subjects.
 - ➤ The result sheet of Wireless Operators of Batch No. 25/23 was placed before the members of BOC for Training and BoC approved the same.
- 2. Approval of syllabus of 03 weeks (15 working days) refresher training for promotion from the rank of Wireless Supervisor (Operational) Grade-II to Grade-I and Wireless Supervisor (Technical) Grade-II to Grade-I. The syllabus was placed before the members of BOC for Training and BOC approved the same with suggestion to include few classes on computer software and cybercrime. DIG Telecom-II agreed to incorporate the same.
- 3. DIG Telecom II was requested to provide question bank for final examination in technical subjects for directly recruited wireless operators and supervisors (Grade II) and send the same to SVSPA by March 2024.
- 4. With regard to final examination in technical subjects for wireless operators currently undergoing training at PTS Salua, ADG Training requested DIG Telecom II to offer his views on the suitability of holding part examination after completion of institutional training at PTS Salua after reviewing the course structure. SVSPA will conduct the final examination as per his suggestions.

Sub.: Creation of 5 (five) new Police Sub-Divisions with posts of SDPO, Maheshtala and SDPO, Bishnupur under Diamond Harbour Police District, SDPO, Mandirbazar under Sundarban Police District, SDPO, Chanditala under Hooghly (Rural) Police District and SDPO, Naxalbari under Darjeeling District by surrendering 5 (five) existing post of DSPs namely 1) DSP, Industrial, 2) DSP, Bishnupur, 3) DSP, Mandir Bazar, 4) DSP, Chanditala and 5) DSP, Siliguri respectively.

This Department has received a proposal from West Bengal Police Directorate vide Memo. No. 228/ORG/ORG-106/2020, dated 24.02.2023 for creation of 5 (five) new Police Sub-Divisions with posts of (1) SDPO, Maheshtala under Diamond Harbour Police District, (2) SDPO, Bishnupur under Diamond Harbour Police District, (3) SDPO, Mandirbazar under Sundarban Police District, (4) SDPO, Chanditala under Hooghly (Rural) Police District and (5) SDPO, Naxalbari under Darjeeling District. These zones are already in existence in these districts and are manned by the Deputy Superintendent of Police posted for the same. Thereafter, the aforesaid Notification was kept in abeyance until further orders vide Notification No. 2558- PL/PB/14M-04/15 dated 07.11.2023.

Meanwhile, West Bengal Police Directorate has come up- with a modified proposal vide No. 50/ORG dated 19.01.2024.

No. 612-PL, dated 27.02.2019 2will b3 435qin3e in CID, West Bengal. 34 Cyber Crime Police Stations functioning under administrative control of concerned Commissioners and Superintendents of Police will be kept under supervision of WB-CCW as mentioned in the Notification No. 2791- PL/PB/14M-04/15 dated 17.10.2023.
- c) West Bengal Cyber Crime Wing will function with already created 188 (134 regular posts + 54 IT personnel by engagement) posts as mentioned in the Notification dated 17.10.2023.
