## MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 03/03/2025

A meeting of the Board of Control for Examination and Promotion was held on 03/03/2025 at 12:00 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

Shri Ajey Mukund Ranade, IPS, Additional Director General & Inspector General of Police (Administration), West Bengal, the Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting:-

- 1. Smt. Krishnakali Lahiri, IPS, Deputy Inspector General of Police (Planning & Welfare), West Bengal.
- 2. Shri Arindam Dutta Chowdhury, IPS, Deputy Inspector General of Police (Administration), West Bengal.
- 3. Shri Amit Kumar Singh, IPS, Vice Principal, SVSPA, Barrackpore in the rank of DIG, Coopted member.
- 4. Shri Sunil Kumar Yadav, IPS, Deputy Inspector General of Police, Coastal Security, WB holding additional charge of DIG (Provisioning), West Bengal, Co-opted member.
- 5. Shri Dipanjan De, Sr. Deputy Secretary to the Govt. of West Bengal, Home and Hill Affairs Department, Nabanna, Howrah.

The following points were discussed in the meeting of BOC for Examination & Promotion.

- To examine and approve Result of the Final Examination of Post-Promotional Training Course who got promoted to the rank of ASI(UB) and Pre-Promotional of Training Course of Constable for Promotion to the rank of ASI(UB) of Batch No. 19/2024.
  - ➤ IGP, SVSPA, WB, Barrackpore has sent memo no.- SVSPA/Exam.Sec/PPT/Const.(UB)/05 (XII)/2018-564 dated 21/02/2025, containing the result of the Final Examination of Post-Promotional Training Course of ASI(UB) and Pre-Promotional of Training Course of Constable for Promotion to the rank of ASI(UB) of Batch No. 19/2024 commenced on and from 23/10/2024 and ended on 16/12/2024 vide Police West Bengal Org No. 267-CRO//CRO-102/2024 and Org No. 266-CRO//CRO-102/2024 dated 26/09/2024.
  - > Total 522(five hundred twenty two) candidates joined at SVSPA, WB and STC SAP 1<sup>st</sup> Bn., BKP (261+261) for the said training. Out of them 08(Eight) trainees returned to unit. Thus, 514 trainees appeared in the Final Examination and qualified successfully.

> The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

**DECISION:** The Board examined the result and approved the same for next course of action. Total 514 (Five hundred fourteen) trainees have been qualified the Pre/Post-Promotional training for promotion to the rank of ASI(UB). Total 08(Eight) trainees (SL No. 3, 84, 88, 145, 156, 231, 241, 350) have returned to their concerned units without completion of Post-Promotional training.

Superintendent of Police- Purulia / Baruipur PD / Birbhum / Purba Bardhaman / Hooghly Rural; Special Superintendent of Police- CID, WB; Superintendent of Railway Police- Howrah GRP / Sealdah GRP will ensure that the officers who have returned without completion of Post Promotional Training, should undergo the Post Promotional Training in next batch.

- To examine and approve Result of the Final Examination of Post-Promotional Training Course who got promoted to the rank of ASI(AB) and Pre-Promotional Training Course of Constable for Promotion to the rank of ASI(AB) of Batch No. 20/2024.
  - ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/Const.(AB)/06 (XIII)/2018-410 dated 07/02/2025 containing the Result of the Final Examination of Post-Promotional Training Course of ASI(AB) and Pre-Promotional Training Course of Constable for Promotion to the rank of ASI(AB) of Batch No. 20/2024 commenced on and from 23/10/2024 ended on 16/12/2024 vide Police WB Org No. 268-CRO//CRO-103/2024 dated 26/09/2024 and Org No. 269-CRO//CRO-103/2024 dated 26/09/2024.
  - ➤ Total 595(five hundred ninety five) candidates reported at PTS, Salua and STC, EFR 2<sup>nd</sup> Bn. to undergo the aforesaid training course. Out of them 03 candidates returned to unit from PTS Salua as well as 01 candidate expired and 03 candidates returned to unit from STC EFR 2<sup>nd</sup> Bn, Salua. Thus 588 trainees appeared in the Final Examination in all subjects and qualified successfully.
  - > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

**<u>DECISION</u>**: The Board examined the result and approved the same for next course of action. Total 588 candidates have been qualified the Pre/Post-Promotional training for promotion to the rank of ASI(AB). Total 06(six) trainees (SL No.

119, 146, 183, 382, 403, 485) have returned to their concerned units without completion of Post-Promotional training.

Commandants- SAP  $13^{th}$  Bn. / SAP  $7^{th}$  Bn. / SSF Bn. / RAF  $2^{nd}$  Bn. / STRA Bn., Purulia / SAP  $11^{th}$  Bn. will ensure that the officers who have returned without completion of Post Promotional Training, should undergo the Post Promotional Training in next batch.

- 3. To examine and approve Result of the Final Examination of Pre/Post-Promotional Training Course for confirmation to the rank of SI(UB) of Batch No. 36/2024.
  - FIGP, SVSPA, WB, Barrackpore has sent memo no.- SVSPA/Exam Cell/PPT/ASI(UB)/03(XX)/ 2018-409 dated 07/02/2025, containing the Result of the Final Examination of Pre/Post-Promotional Training Course for confirmation to the rank of SI(UB) of Batch No. 36/2024 commenced on and from 25/11/2024 and ended on 24/12/2024 vide Police WB, Org No. 304-CRO//CRO-104/2024 dated 05/11/2024.
  - > Total 150 candidates [146 SI(UB) + 4 ASI(UB)] reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. Out of them 01 SI(UB) returned to unit on medical ground. Thus 149 trainees appeared in the Final Examination in all subjects and qualified successfully.
  - > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.
    - **DECISION:** The Board examined the result and approved the same for next course of action. Total 149 trainees have been qualified the Pre/Post-Promotional training for promotion to the rank of SI(UB). One SI(UB) Rajesh Kumar Sonar (SI No. 63) of Birbhum has returned to unit on medical ground without completion of Post Promotional Training.

Superintendent of Police, Birbhum will ensure that the officer should undergo Post Promotional Training in next batch.

- 4. To examine and approve Result of the Final Examination of Pre/Post-Promotional Training Course for promotion / confirmation to the rank of SI(AB) of Batch No. 29/2024.
  - > IGP, SVSPA, WB, Barrackpore has sent memo no.-SVSPA/Exam.Cell/PPT/ASI(AB)/04(XVII)/ 2018-565 dated 21/02/2025, containing the Result of the Final Examination of Pre/Post-Promotional Training Course for promotion / confirmation to the rank of SI(AB) of Batch No. 29/2024 commenced on and from

- > Total 159(one hundred fifty nine) ASIs (AB) reported at SVSPA, WB, Barrackpore to undergo the aforesaid training. Out of then 01(one) candidate returned to unit on MC. Remaining 158 appeared in the Final Examination. Out of them 149 candidates qualified successfully and 09 candidates did not qualify on Weaponry subject (outdoor subject).
- > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.
  - **DECISION:** a) The Board examined the result and approved the same for next course of action. Total 149 candidates have been qualified the Pre/Post-Promotional training for promotion to the rank of SI (AB).
    - **b)** Total 09(nine) candidates (SL No. 51, 54, 59, 61, 63, 64, 75, 81, 96) who did not qualify on weaponry subject (outdoor subject) should be imparted training for 07(seven) days at District / Unit in which they are presently posted. IGP, SVSPA, WB will issue necessary direction / training schedule and ensure conduct of 07(seven) days training for the candidates by their respective unit heads and arrange for examination after getting adequate knowledge of weaponry by them.

# 5. To open and examine the sealed cover in r/o C/548 Tanmoy Pal of Jhargram for promotion to the rank of ASI(UB).

It is to note that a letter has been received from SP, Jhargram vide Memo No. 223/RO JRM dated 12/02/2025 inter-alia stated that C/548 Tanmoy Pal (WBP ID 2007004517) of Jhargram District who prayed for consideration of his promotion to the next higher rank i.e. ASI(UB), with retrospective effect and with all service benefits.

BOC (E&P) held on 07/02/2024, 08/02/2024 and 22/02/2024 decided to keep the promotion matter of C/548 Tanmoy Pal as 'CLOSED COVER' (50 point Roster SI No. 254) due to pendency of court case in Moyna PS, Dist.- Purba Medinipur vide Moyna PS Case No. 241/2022, dated 18/09/2022 u/s 498A/304B/34 IPC. Charge Sheet No. 341/22, dated 31/12/2022 u/s 498A/306/34 IPC.

Thereafter, he had further submitted willingness for promotion to the rank of ASI(UB). Accordingly BOC (E&P) held on 13/08/2024, 14/08/2024 and 16/08/2024 opened the 'CLOSED COVER' in r/o C/548 Tanmoy Pal and that status of pending criminal proceedings (the case was under trial and next date of hearing was on 13/09/2024) against him was

examined and BOC (E&P) decided to keep the promotion matter of C/548 Tanmoy Pal again as 'CLOSED COVER'.

Finally, the Ld. Court ordered on 21/01/2025 that the FIR named accused Tanmoy Pal is not found guilty of the offence punishable under 498A/304B/306/34 of IPC and he is acquitted under section 235(1) of CrPC.

The matter is placed before the BOC (E&P) for its consideration.

**DECISION:** The BOC(E&P) held on 07/02/2024, 08/02/2024 and 22/02/2024 had unanimously decided to keep the promotional vacancy in respect of C/548 Tanmoy Pal as **'CLOSED COVER'** procedure in view of the pending Criminal Case against him.

Further, BOC (E&P) held on 13/08/2024, 14/08/2024 and 16/08/2024 examined the promotion matter of C/548 Tanmoy Pal and tallied with the then status of court case pending against him and decided to continue the 'CLOSED COVER'.

The Members of the BOC(E&P) opened, examined and disposed off the Closed Cover kept against C/548 Tanmoy Pal of Jhargram. The members of BOC(E&P) examined the judgement passed by Ld. Additional District and Session Judge, Purba Medinipur, received from SP Jhargram and found that the said C/548 Tanmoy Pal has been acquitted from the said criminal proceeding.

Now, the members of BOC(E&P) unanimously decided that C/548 Tanmoy Pal of Jhargram is **"Fit"** for promotion to the rank of ASI(UB). He will get seniority from his immediate junior C/285 Rameshwar Kumar of Howrah GRP who got promoted to the rank of ASI(UB) and posted to Howrah GRP on promotion vide Memo No. 114(168)CRO//CRO-80/2023 dated 29/02/2024. He will get all consequential service benefits notionally. However, he will get his actual benefit from the date of assuming superior charge as ASI(UB).

## MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 13/03/2025

A meeting of the Board of Control for Examination and Promotion was held on 13/03/2025 at 12:30 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

Shri Ajey Mukund Ranade, IPS, Additional Director General & Inspector General of Police (Administration), West Bengal, the Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting:-

- 1. Smt. Krishnakali Lahiri, IPS, Deputy Inspector General of Police (Planning & Welfare), West Bengal.
- Shri Arindam Dutta Chowdhury, IPS, Deputy Inspector General of Police (Administration), West Bengal.
- 3. Shri Amit Kumar Singh, IPS, Vice Principal, SVSPA, Barrackpore in the rank of DIG, Coopted member.
- 4. Shri Joy Biswas, IPS, Deputy Inspector General of Police, (Provisioning), WB.
- 5. Shri Dipanjan De, Sr. Deputy Secretary to the Govt. of West Bengal, Home and Hill Affairs Department, Writers' Building.
  - The following points were discussed in the meeting of BOC for Examination & Promotion.
- 1. Promotion matter of C/781 Sankar Basu(WBP ID- 2003062638) of Barasat PD who was earlier posted on promotion as ASI(AB) to STRA Bn. Purulia and deputed to Barrackpore PC.
  - ➢ BOC(E&P) held on 13/08/2024, 14/08/2024 & 16/08/2024, C/781 Sankar Basu of Barasat PD was declared "FIT" for promotion (50 point roster no. 61). Accordingly promotion-cum-posting order had been issued in respect of C/781 Sankar Basu of Barasat PD to assume his superior charge as ASI(AB) to STRA Bn. Purulia and deputed to Barrackpore PC vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024. However, the constable was not given departure as departmental proceedings vide Barasat PD proceeding no. 03 dated 24/02/2025 was drawn up against him for his unauthorised absent from Govt. duties.

The matter is placed before BOC(E&P) for decision.

**DECISION:** After perusal of records and report received from SP, Barasat PD vide org no. 206/RO(F) dated 25/02/2025 it is found that C/781 Sankar Basu of Barasat PD was provisionally promoted to the rank of ASI(AB) and posted to STRA Bn. Purulia and deputed to Barrackpore PC vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024. His name is in sl no. 57 of the said provisional promotion-cum-posting order. He was accorded provisional promotion to the next higher rank as he was found "FIT" on that point of time subject to that he is not facing any departmental proceeding, criminal case or proceeding before the Vigilance commission and is not presently under any currency of punishment.

The Board unanimously decided that in view of the Departmental Proceeding pending against the said C/781 Sankar Basu of Barasat PD before assuming his superior charge, the promotion-cum-posting order dated 07/09/2024 in respect of C/781 Sankar Basu of Barasat PD is hereby "Cancelled".

The promotional vacancy in respect of C/781 Sankar Basu of Barasat PD is kept in "Closed Cover" procedure in view of the pending departmental proceeding against him. The sealed L-C-R-S sheets which was examined by the BOC(E&P) on 13/08/2024, 14/08/2024 & 16/08/2024 was reopened and necessary noting has been incorporated in respect of C/781 Sankar Basu in view of this recent development (pending departmental proceeding) which has been signed by all members present in the BOC(E&P) including Chairman.

SP, Barasat PD is directed not to release him to assume his superior charge to the rank of ASI(AB). The matter should be incorporated in the service book of C/781 Sankar Basu.

- 2. Promotion matter of C/1108 Pritam Barman (WBPD ID- 2004011813) of Siliguri PC who was earlier posted on promotion as ASI(AB) to Gorkha Bn. and deputed to Kalimpong.
  - ➤ BOC(E&P) held on 13/08/2024, 14/08/2024 & 16/08/2024, C/1108 Pritam Barman of Siliguri PC was declared "FIT" for promotion (50 point roster no. 71). Accordingly promotion-cum-posting order had been issued in respect of C/1108 Pritam Barman of Siliguri PC to Gorkha Bn. and deputed at Kalimpong for the rank of ASI(AB) vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024.
  - C/1108 Pritam Barman of Siliguri PC has not been given departure as he is presently admitted at "NEW LIFE FOUNDATION RE-HAB" of Kolabari, Debidanga, Champasari, Siliguri w.e.f. 17.01.2025 till date due to alcoholism. DCP(HQ), Siliguri PC under his memo no. 465/RO, SPC dated 04/03/2025 enclosed a case summery and health status of the said constable received from the Re-hab Centre wherein it has been mentioned that Pritam Barman might need couple of weeks to recover fully and perform his normal duties.

The matter is placed before BOC(E&P) for decision.

**DECISION:** After perusal of the records, it is found that C/1108 Pritam Barman of Siliguri PC was provisionally promoted to the rank of ASI(AB) and posted to Gorkha Bn. and deputed at Kalimpong vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024. His name is in sl no. 73 of the said provisional promotion-cum-posting order. He was accorded provisional promotion to the next higher rank as he was found "FIT" on that point of time.

After examining the documents received from DCP(HQ) Siliguri PC the Board unanimously decided that in view of the present health condition of C/1108 Pritam Barman who is at present admitted in Rehabilitation centre for his recovery from Alcholism, his promotion order is kept in abeyance for the present. CP, Siliguri PC will arrange for a medical board with the consultation of CMO(H) Siliguri to determine the health status of C/1108 Pritam Barman

of Siliguri PC and send it to DIG(A), WB for placing the same before the next BOC(E&P) for further decision. In the mean time C/1108 Pritam Barman of Siliguri PC should not be released to assume his superior charge to the rank of ASI(AB).

- 3. Prayer of ASI(UB)/2219 Haridas Brahma of Chandanngar PC regarding allowing 25 years CAS benefit who forgo his promotion to the rank of SI(UB).
- ▶ DCP (HQ), CPC vide memo no. 2854/RO, CPC dated 02/12/2024 has forwarded the petition dated 28/11/2024 submitted by ASI (UB)/2219 Haridas Brahma of Chandannagar PC that during his incumbency at Howrah PC, promotion order vide memo no. 278(168)/Per/A//Per/A-27/2019 dated 30/07/2019 of DIG(A), WB was issued against his name without obtaining willingness from him. Subsequently, he had submitted unwillingness to take promotion as SI(UB) due to his acute illness. However he was not allowed 25 years CAS benefit. In this regard an order was done by Howrah PC vide CO No. 1622 dated 01/06/2021 in compliance of memo no. 452(7)-Per/A//Per/A-27/2019 dated 07/10/2020 of DIG(HQ), WB.
- > DCP(HQ), CPC in the above memo has also mentioned that there is no order had been pasted in his service book regarding his willingness to take promotion to the rank of SI(UB) before issuing the said promotion order.

The matter is placed before BOC(E&P) for decision.

**DECISION:** The Board examined the relevant documents and it has been transpired that the prayer of ASI (UB)/2219 Haridas Brahma of Chandannagar PC while posted in Howrah PC for "Forgoing" promotion to the rank of SI(UB) was placed before the BOC(E&P) held on 31<sup>st</sup> July 2020 and the Board asked the respective CP to strictly follow the G.O. no. 9120-F dated 13/11/2000, of Finance Department Audit Branch, Govt. of West Bengal. The officer concerned will not be entitled to get any benefit under CAS 1990 and it should be recorded in his service book. Also, as on date there is no express provision in PRB/Police Order regarding un-willingness of police personnel for promotion.

The Board unanimously decided to uphold the decision of BOC(E&P) held on 31<sup>st</sup> July 2020. Thus the petition dated 28/11/2024 of ASI (UB)/2219 Haridas Brahma of Chandannagar PC received through DCP (HQ), CPC vide memo no. 2854/RO, CPC dated 02/12/2024 is "disposed off".
