MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 08/04/2025

A meeting of the Board of Control for Examination and Promotion was held on 08/04/2025 at 12:00 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

Shri Ajey Mukund Ranade, IPS, Additional Director General & Inspector General of Police (Administration), West Bengal, Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting:-

- 2. Shri Arindam Dutta Chowdhury, IPS, Deputy Inspector General of Police (Administration), West Bengal.
- 3. Shri Amit Kumar Singh, IPS, Vice Principal, SVSPA, Barrackpore in the rank of DIG, Co-opted member.
- 4. Shri Joy Biswas, IPS, Deputy Inspector General of Police, (Provisioning), WB.
- 5. Shri Dipanjan De, Sr. Deputy Secretary to the Govt. of West Bengal, Home and Hill Affairs Department, Writers' Building.

The following points were discussed in the meeting of BOC for Examination & Promotion.

1. To examine and approve result of the final examination of Post-Promotional Training Course for confirmation to the rank of Inspector of Police (UB) of Batch No. 33/2025.

- ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. File No. SVSPA/Exam Sec/SI(UB)/01 (XI)/2018-842 dated 19/03/2025 containing the Result of the Final Examination of Post-Promotional Training Course for confirmation to the rank of Inspector of Police (UB) of Batch No. 33/2025 commenced on and from 20/01/2025 ended on 19/02/2025 vide Police WB Org No. 17-CRO//CRO-10/2023 dated 15/01/2025 and Org No. 21-CRO//CRO-10/2023 dated 16/01/2025.
- > Total 121(one hundred twenty one) Inspectors (UB) reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. They appeared in all subjects of the Final Examination after completion of the training and qualified successfully.
- > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

<u>**DECISION:**</u> The Board examined the result and approved the same for next course of action. Total 121(one hundred twenty one) Inspectors (UB) have been qualified the Post-Promotional training for confirmation to the rank of Inspector of Police (UB).

2. To examine and approve result of the final examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT) of Batch No. 01/2025.

- ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(MT)/07 (I)/2025-843 dated 19/03/2025 containing the Result of the final examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT) of Batch No. 01/2025 commenced on and from 20/01/2025 ended on 03/03/2025 vide Police WB Org No. 12-CRO//CRO-07/2025 dated 11/01/2025.
- > Total 66(sixty six) candidates reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. Thus, 66 trainees appeared in all subjects of the final examination and qualified successfully.
- > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined the result and approved the same for next course of action. Total 66(sixty six) ASI(MT) have been qualified the Post-Promotional training for confirmation to the rank of ASI(MT).

3. To examine and approve result of the final examination of Pre Promotional Training Course of ASI(AB) for promotion to the rank of SI(AB) of Batch No. 30/2025.

- ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(AB)/04 (XVII)/2018-925 dated 25/03/2025 containing the result of the final examination of Pre-Promotional Training Course of ASI(AB) for Promotion to the rank of SI(AB) of Batch No. 30/2025 commenced on and from 20/01/2025 ended on 21/02/2025 vide Police WB Org No. 20-CRO//CRO-105/2024 dated 16/01/2025.
- > Total 283(two hundred eighty three) ASI(AB)/SI(AB) reported at SVSPA, WB (47 Candidates) & PTS Salua (236 Candidates) to undergo the aforesaid training course. Out of them 01 candidate returned to unit from PTS Salua for his incapability in Outdoor activities. The remaining 282 Candidates appeared in the final examination and qualified successfully.
- > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined the result and found that out of 283 candidates 282 candidates have been qualified the Pre-Promotional training for promotion to the rank of SI(AB). One candidate namely ASI(AB)/278 Atanu Panigrahi of Purba Mrdinipur (SI. no. 144 of the result sheet) returned to his unit without completion of Pre-Promotional training due to his incapability in Outdoor activities.

Hence, the BOC(E&P) unanimously approved the result of 282 candidates who have been qualified the Pre-Promotional training for promotion to the rank of SI(AB).

The name of the ASI(AB)/278 Atanu Panigrahi of Purba Medinipur will not be considered in the Range Board for promotion to the rank of SI(AB), unless he completes the Pre-Promotional training.

SP, Purba Medinipur shall incorporate the decision in the Service Book of ASI(AB)/278 Atanu Panigrahi.

4. To examine and approve result of the final examination of Pre/Post Promotional Training Course for Promotion/confirmation to the rank of SI(UB) of Batch No. 37/2025.

- ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(UB)/03 (XIX)/2018-923 dated 25/03/2025 containing the result of the final examination of Pre/Post Promotional Training Course for Promotion/confirmation to the rank of SI(UB) of Batch No. 37/2025 commenced on and from 20/01/2025 ended on 21/02/2025 vide Police WB Org No. 14-CRO//CRO-104/2024 dated 13/01/2025.
- > Total 453(four hundred fifty three) candidates reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. Out of them 02 SI(UB) returned to unit. Thus 451 trainees appeared in the final examination and out of them, 01 candidate did not qualify in Paper-III & did not appear in Paper-II and remaining 450 trainees qualified in all subjects.
- > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined the result and found that out of 453 candidates 450 candidates have been qualified the Pre/Post Promotional Training Course for Promotion/confirmation to the rank of SI(UB).

Two candidates namely ASI(UB)/1555 Dhirendra Mohan Mondal of Chandannagar PC (Sl. no. 277 of the result sheet) and ASI(UB)/281 Puspen

Ghosh of Hooghly Rural (SI. no. 312 of the result sheet) have returned to their unit without completion of Pre/Post Promotional training. One candidate namely ASI(UB)/1621 Abul Basar Ali of Murshidabad PD did not qualify in Paper-III & did not appear in Paper-II of the examination.

Hence, the BOC(E&P) unanimously approved the result of 450 candidates who have been qualified the Pre/Post Promotional training for promotion to the rank of SI(UB).

The names of the ASI(UB)/1555 Dhirendra Mohan Mondal of Chandannagar PC and ASI(UB)/281 Puspen Ghosh of Hooghly Rural will not be considered in the Range Board for promotion to the rank of SI(UB), unless they completed the Pre-Promotional training.

CP, Chandannagar PC and SP, Hooghly Rural shall incorporate the decision of the BOC(E&P) in their Service Book.

IGP, SVSPA, WB will ask SP, Murshidabad PD well in advance to direct ASI(UB)/1621 Abul Basar Ali of Murshidabad PD to appear in Paper-II and Paper-III in the next supplementary examination.

5. Promotion matter of C/2630 Sufal Chandra Patra of Howrah PC who was earlier posted on promotion as ASI(AB) to Khagragpur GRP.

- ➢ BOC(E&P) held on 13/08/2024, 14/08/2024 & 16/08/2024, C/2630 Sufal Chandra Patra of Howrah PC was declared "FIT" for promotion after rotating 50 point roster. Accordingly, promotion-cum-posting order had been issued in respect of C/2630 Sufal Chandra Patra of Howrah PC to assume his superior charge as ASI(AB) to Kharagpur GRP vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024. However, the Constable was not given departure as departmental proceedings vide Howrah PC proceeding no. 01/25 dated 30/01/2025 was drawn up against him as a specific Case was started against him vide Golabari PS Case No. 259 dated 12.08.2024 U/S-69/351(3) BNS and ended in Charge Sheet vide Golabari PS Charge Sheet No. 310/2024 dated 07.10.2024 u/s 69/351(3) BNS.
- > The matter is placed before BOC(E&P) for decision.

DECISION: After perusal of the records and report received from DCP(HQ), Howrah PC vide memo no. 966/RO dated 07/04/2025 it is found that C/2630 Sufal Chandra Patra of Howrah PC was provisionally promoted to the rank of ASI(AB) and posted to Kharagpur GRP vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024. His name is in sl no. 331 of the said provisional promotion-cumposting order. He was accorded provisional promotion to the next higher rank

as he was found "FIT" at that point of time, subject to condition that he is not facing any departmental proceeding, criminal case or proceeding before the Vigilance commission and is not presently under any currency of punishment. However, C/2630 Sufal Chandra Patra of Howrah PC was not released as a Criminal Case was started against him and ended in Charge Sheet. Also, a departmental Proceeding was drawn up against him.

The Criminal proceedings as well as departmental proceedings are pending against the said police personnel.

Hence, considering the facts above, the Board unanimously decided to "Cancel" the promotion-cum-posting order in respect of C/2630 Sufal Chandra Patra of Howrah PC to Kharagpur GRP vide memo no. 552(168)/CRO//CRO-81/2023 dated 07/09/2024.

However, the promotional vacancy in respect of C/2630 Sufal Chandra Patra of Howrah PC is kept in "Closed Cover" procedure in view of the pending Criminal Proceedings and departmental proceedings against him. The sealed L-C-R-S sheets which was examined by the BOC(E&P) on 13/08/2024, 14/08/2024 & 16/08/2024 is reopened and necessary noting has been incorporated in respect of C/2630 Sufal Chandra Patra in view of this recent development (pending Criminal Proceedings and departmental proceedings) which has been signed by all members present in the BOC(E&P) including Chairman.

DCP(HQ), Howrah PC is directed not to release him to assume his superior charge to the rank of ASI(AB). The matter should be incorporated in the service book of C/2630 Sufal Chandra Patra.

If found not genuine, recommendation be sent to DIG (A), WB for their transfer out of the Commissionerate / District.

NOTIFICATION

The question of revision of remuneration of drivers engaged directly in Government establishments including Boards, Corporations, Statutory Bodies and Undertakings against sanctioned posts on contractual basis with approval of the Finance Department has been under active consideration of the Government for some time past.

After careful consideration of the matter, the undersigned is directed by order of the Governor to say that the Governor has been pleased to decide as follows :

i) With effect from the 1st January, 2025, the consolidated monthly remuneration of above category of drivers engaged on contractual basis will be revised in the following manner:

Category: Contractual Driver

1.	On initial engagement	Rs. 16,000
2.	On completion of 5 years from initial engagement	Rs. 20,000
3.	On completion of 10 years from initial engagement	Rs. 25,000
4.	On completion of 15 years from initial engagement	Rs. 31,000
5.	On completion of 20 years from initial engagement	Rs. 38,000

- ii) Remuneration may be fixed in the above revised remuneration structure based on the number of completed years since initial engagement without any break.
- iii) This will be applicable for the drivers till attaining the age of 60 years subject to renewal of the engagement.
- iv) The engaging authority will check and verify that the conditions stated in the first paragraph above are fulfilled before allowing the benefit of revised remuneration.
- v) The base remuneration of drivers engaged through agency will be Rs. 16,000/- per month. Other charges as applicable for hiring through agency will conti8nue to apply.

NOTIFICATION

No. 1119-PL/PB/14M-10/2025 dated 21.04.2025—In exercise of the power conferred by section 2A of the Police Act, 1861 (5 of 1861) and in appropriate modifications of all previous rules/ orders on the subject, the Governor is pleased hereby to make the following rules regulating the direct recruitment of Medal Winner Sports Persons under special dispensation to the posts of **Constables** in the West Bengal Police Force under the Home and Hill Affairs Department, Government of West Bengal, namely,—

Rules

1. Short title, application and commencement -- (1) These rules may be called the Combined Recruitment Rules for Direct Recruitment of Medal Winner Sports Persons under Special Dispensation in the Posts of Constables in the West Bengal Police Force, 2025. (2) They shall come into force on the date of their publication in the Official Gazette.

They shall apply for direct recruitment of medal winner sports persons in the post of **Constables** in the West Bengal Police Force under special dispensation by the appropriate authority of West Bengal Police Directorate throughout the jurisdiction of West Bengal Police under the Police Act, 1861.

- 2. **Definitions**–(1) In these rules, unless the context other wise requires,–
- (i) "the Act" means the Police Act, 1861 (5of 1861);
- (ii) "Appropriate authority" means the appropriate authority as may be appointed by the State Government;
- (iii) "Department" means the Department of Home and Hill Affairs, Government of West Bengal;
 - (iv) "Directorate" means the West Bengal Police Directorate under the Department;
 - (v) "Government" means the State Government of West Bengal;
- (vi) "Third Gender" means a transgender person as defined in clause (k) of section 2 of the Transgender Persons (Protection of Rights) Act, 2019 (40 of 2019).

(2) Words and expressions not defined herein but defined in the Act, shall be deemed to have the same meaning as respectively assigned to them in the Act.

- 3. **Method of recruitment** Notwithstanding anything provided in any other rules on the subject, orders or notifications, medal winner sports persons in select sports events/championships may be appointed directly under special dispensation to the post of **Constables** under West Bengal Police Force in the manner and on fulfillment of such criteria and conditions as prescribed under this rules.
- 4. **Recruitment Authority**–(1) The recruitment to the post of **Constables** in West Bengal Police Force shall be made by the Appropriate authority of the Directorate upon approval of the State Government.
- 5. **Eligibility** The eligibility criteria for direct recruitment of medal winner sports persons in select sports events/championships under special dispensation to the post of **Constables** under West Bengal Police Force shall be as follows:
- a) The applicant must be a citizen of India;
- b) Male, Female and Third Gender candidates are eligible for recruitment in such category;
- c) Age The applicant must not be less than 18 (eighteen) years old and must not be more than 35 (thirty five) years old on the date of application:

Provided that the upper age limit shall be relaxable by 05 years in case of Scheduled Caste and Scheduled Tribes candidates, by 03 years in case of Other Backward Classes candidates and by 03 years in case of Third Gender Persons. Provided further that the State Government reserves the right to relax the candidates in deserving cases for the reasons mentioned in the order of relaxation.

d) Educational qualification – The candidate must have passed Madhyamik Examination from the West Bengal Board of Secondary Education or its equivalent examination:

Provided that the medal winner sports persons who may not have the minimum educational qualification as prescribed hereinbefore may also be considered for appointment as **Constables** in West Bengal Police Force subject to the condition that they shall have to obtain necessary educational qualification in due course before confirmation in the post.

- (e) Winning of Medals: The candidate must have won the medal in selected sports events/championships as may be required for the post and as may be specified by the State Government by notification
- (f) The candidate should meet the minimum physical measurement criteria as laid down in rule 6.
- 6. Physical Measurement Test (PMT) The candidates being considered for recruitment as Constables in the West Bengal Police Force in the category of medal winner sports persons in select sports events/championships under special dispensation shall undergo Physical Measurement Test (PMT) which will be conducted by the West Bengal Police Recruitment Board and must meet the minimum physical standards as mentioned below subject to the condition that Physically Disabled Persons are not entitled to be recruited in West Bengal Police Force due to service condition:
 - (i) PMT for the Male candidates:-

Provided that the State government may condone the required standards of physical measurement criteria in special cases for the reasons to be recorded in the condonation order.

7. Verification of Character Antecedents– All provisionally selected candidates shall be required to fill up a Verification Roll which shall be thoroughly enquired into by the concerned authority.

8. Medical Examination—

(a) All provisionally selected candidates shall be required to appear for Medical Examination at the hospitals designated by the State Government for the purpose. The candidate should qualify the prescribed Medical Test. The candidates must not have knock knee, flat foot, varicose vein, squint eyes. The minimum vision should be 6/6 with or without glasses. They should possess high colour vision and should not be colour blind. The medical test shall also include the chest x-ray and other tests as prescribed by the Department of Health and Family Welfare, Government of West Bengal from time to time. The selected candidate should be in good mental and physical health and free from any physical deformity and disability likely to interfere with the training and efficient performance of the duties as Police officer. The certificate of fitness shall be issued by

the authorized Medical Officer.

- 9. **Appointing Authority**—Assistant Inspector General of Police or Superintendent of Police or Commandant, as the case may be will act as the Appointing Authority for the post of **Constables** in West Bengal Police Force
- 10. **Appointment, Training and Probation** (1) The candidates provisionally selected for appointment to the post of Constable shall, after successful completion of Verification of Character Antecedents and Medical Examination, be appointed on temporary basis. Such candidates shall be placed on probation for 01 (two) years from the date of joining.
- (2)They shall be required to undergo a prescribed course of training in accordance with the Police Regulations, Bengal and/or such rules and regulations as prescribed by the State Government.
- (3) Upon completion of the period of probation, they may be confirmed in service by the competent authority subject to their satisfactorily completing of the course of training as well as passing the departmental examination as may be prescribed and also subject to their having the minimum educational qualification as provided in rule 5.

11. Discharge-

(a) A **Constable** may, anytime during the period of probation or while undergoing training, be discharged simpliciter from service by the competent authority, without proceedings, if found unsuitable for the post.

The order of discharge shall include the grounds of discharge, but no formal proceeding shall be necessary. The order of discharge shall not be given effect to until the same is confirmed by the next higher authority.

(b) No appeal shall lie against the order of discharge.

12. Seniority-

The seniority in the post of Constable in the West Bengal Police Force recruited under these rules shall be on the basis of their dates of joining provided that in case of candidates joining the post on the same date, the inter se seniority will be according to the dates of winning the qualifying medal(s) and the dates of winning the qualifying medal(s) also being the same, the seniority of the candidates will be according to the dates of birth. The candidates having the earlier date of birth will get precedence in terms of seniority.

13. **Saving**- (1) Nothing in these rules shall confer upon any person any right to be appointed as an Constables in the West Bengal Police Force in the category of medal winner sports persons under special dispensation and the State Government reserves the right to reject the candidature of any candidate without assigning any reason whatsoever.
