No. 1118-PL/PB/14M-47/2023 dated 21.04.2025 – In exercise of the power conferred by section 2A of the Police Act, 1861 (5 of 1861) and in partial modifications of all previous rules on the subject, the Governor is pleased hereby to make the following rules regulating the direct recruitment of Medal Winner Sports Persons under special dispensation to the posts of **Sub-Inspector of Police (Armed Branch)** in the West Bengal Police Force under the Home and Hill Affairs Department, Government of West Bengal, namely,—

#### Rules

**Short title, application and commencement**– (1) These rules may be called the Direct Recruitment of Medal Winner Sports Persons under Special Dispensation to the Posts of Sub-Inspector of Police (Armed Branch) in the West Bengal Police Force, 2025.

- (2) They shall come into force on and from the date of their publication in the Official Gazette.
- (3) They shall apply for direct recruitment of medal winner sports persons in the posts of Sub-Inspector of Police (Armed Branch) in the West Bengal Police Force under special dispensation by the appropriate authority of West Bengal Police Directorate throughout the jurisdiction of West Bengal Police under the Police Act, 1861.
  - 2. **Definitions**–(1) In these rules, unless the context otherwise requires,–
  - (i) "the Act" means the Police Act, 1861(5 of 1861);
  - (ii) "Appropriate authority" means the appropriate authority as may be appointed by the State পশ্চিমবঙ্গ আরক্ষা আধিকার, ভবানি ভবন, আলিপুর, কলকাতা- ২৭ ।।

Government;

- (iii) "Department" means the Department of Home and Hill Affairs, Government of West Bengal;
  - (iv) "Directorate" means the West Bengal Police Directorate under the Department;
  - (v) "Government" means the State Government of West Bengal;
- (vi) "Sub-Inspector of Police" means a Sub-Inspector of Police (Armed Branch) in the West Bengal Police Force;
- (vi) "Third Gender" means a transgender person as defined in clause (k) of section 2 of the Transgender Persons (Protection of Rights) Act, 2019 (40 of 2019).
- (2) Words and expressions not defined herein but defined in the Act, shall be deemed to have the same meaning as respectively assigned to them in the Act.
- 3. **Method of recruitment** Notwithstanding anything provided in any other rules, orders or notifications, medal winner sports persons in select sports events/championships may be appointed directly under special dispensation to the post of Sub-Inspector of Police (Armed Branch) in West Bengal Police Force in the manner and on fulfillment of such criteria and conditions as may be specified by the State Government by notification from time to time.
- 4. **Recruitment Authority**–(1) The appointment to the post of Sub-Inspector of Police (Armed Branch) in the West Bengal Police Force shall be made by the appropriate authority of the Directorate upon approval of the State Government.
- 5. **Eligibility** The eligibility criteria for direct recruitment of medal winner sports persons in select sports events/championships under special dispensation to the post of Sub-Inspector of Police (Armed Branch) in West Bengal Police Force shall be as follows:
- a) The applicant must be a citizen of India;
- b) Male, Female and Third Gender candidates are eligible for recruitment in such category;
- c) Age The applicant must not be less than 18 (eighteen) years old and must not be more than 35 (thirty five) years old on the date of application:

Provided that the upper age limit shall be relaxable by 5 (five) years in case of Scheduled Castes and Scheduled Tribes candidates, by 3 (three) years in case of Other Backward Classes candidates and by 3 (three) years in case of Third Gender persons;

Provided further that the State Government reserves the right to relax the upper age limit of the candidates in deserving cases.

d) Educational qualification – The candidate must have a bachelor's degree in any discipline from a

recognized university or its equivalent;

Provided that the medal winner sports persons who may not have the minimum educational qualification as prescribed hereinbefore may also be considered for appointment as Sub-Inspector of Police (Armed Branch) in West Bengal Police Force subject to the condition that they shall have to obtain necessary educational qualification in due course of their job before confirmation in the post.

- (e) Winning of Medals: The candidate must have won the medal in select sports events/championships as may be required for the post and as may be specified by the State Government by notification from time to time. The candidate should meet the minimum physical measurement criteria as laid down in rule 6.
- 6. Physical Measurement Test (PMT) The candidates being considered for recruitment as Sub-Inspector of Police (Armed Branch) in the West Bengal Police Force in the category of medal winner sports persons in select sports events/championships under special dispensation shall undergo Physical Measurement Test (PMT) which will be conducted by the West Bengal Police Recruitment Board and must meet the minimum physical standards as mentioned below:

### (a) For Male candidates:-

Provided that the Government may condone the required standards of physical measurement criteria in special cases.

**7. Verification of Character Antecedents**— All provisionally selected candidates shall be required to fill up a Verification Roll which shall be thoroughly enquired into by the concerned authority.

#### 8. Medical Examination –

All provisionally selected candidates shall be required to appear for medical examination at the hospitals designated by the State Government for the purpose. The candidate should qualify the prescribed Medical Test. The candidates must not have knock knee, flat foot, varicose vein and squint eyes. The minimum vision should be 6/6 with or without glasses. They should possess high colour vision and should not be colour blind. The medical test shall also include the chest x-ray and other tests as prescribed by the Department of Health and Family Welfare, Government of West Bengal, from time to time. The selected candidate should be in good mental and physical health and free from any physical deformity and disability likely to interfere with the training and efficient performance with the duties as Police officer. The certificate of fitness shall be issued by the authorized Medical Officer.

**9. Appointing Authority**—Assistant Inspector General of Police in the Directorate or an officer of equivalent rank, as the case may be, will act as the Appointing Authority for appointment to the post of Sub-Inspector of Police (AB) in West Bengal Police Force under these rules.

# 10. Appointment, Training and Probation—

The Appointment, Probation and Confirmation to these posts shall be guided by the West Bengal Services (Appointment, Probation and Confirmation) Rules, 1979.

The following provision shall also be applicable:-

- (a) The candidates provisionally selected for appointment to the posts of Sub-Inspector of Police (Armed Branch) shall, after successful completion of Verification of Character Antecedents and Medical Examination, be appointed on temporary basis.
- (b) They shall be required to undergo a prescribed course of training in accordance with the Police Regulations, Bengal and/or such rules and regulations as prescribed from time to time. After successful completion of Basic Training, they will be placed on probation for two years;
- (c) Upon completion of the period of probation, they may be confirmed in service by the competent authority subject to their satisfactorily completing the course of training as well as passing the departmental examination as may be prescribed from time to time and also subject to having the minimum educational qualification as provided in rule 5.

#### 11. Discharge-

(a) A Sub-Inspector of Police (Armed Branch) may, anytime during the period of probation or while undergoing training, be discharged from service by the competent authority, without proceedings, if found unsuitable for the post.

The order of discharge shall include the grounds of discharge, but no formal proceedings shall be necessary. The order of discharge shall not be given effect to until its confirmation by the next higher authority.

(b) No appeal shall lie against such order of discharge.

#### 12. Seniority-

The seniority of the officers in the post of **Sub-Inspector of Police (Armed Branch)** in the West Bengal Police Force recruited under these rules shall be on the basis of their dates of joining provided that in case of officers joining the post on the same date, the inter se seniority will be according to the dates of winning the qualifying medal(s) and further that the dates of winning the qualifying medal(s) also being the same, the seniority of the officers will be according to the dates of birth, the officer having the earlier date of birth getting precedence in terms of seniority.

## 13. Saving-

- (a) Nothing in these rules shall confer upon any person any right to be appointed as an Inspector of Police (Armed Branch) in the West Bengal Police Force in the category of medal winner sports persons under special dispensation and the State Government reserves the right to reject the candidature of any candidate or appoint him to a lower post without assigning any reason whatsoever.
- (b) The medal winner sports persons in select sports events/championships who may have already been appointed before coming into force of these rules as Sub-Inspector of Police (Armed Branch) in West Bengal Police Force under special dispensation in terms of the notification issued by the State Government in this regard shall be deemed to have been appointed under these rules.

Provided further that the State Government reserves the right to relax the upper age limit of the candidates in deserving cases for the reasons mentioned in the order of relaxation.

d) Educational qualification – The candidate must have a bachelor's degree in any discipline from a recognized university or its equivalent;

Provided that the medal winner sports persons who may not have the minimum educational qualification as prescribed hereinbefore may also be considered for appointment as Inspector of Police (Armed Branch) in West Bengal Police Force subject to the condition that they shall have to obtain necessary educational qualification in due course of their job before confirmation in the post.

(e) Winning of Medals: The candidate must have won the medal in select sports events/championships as may be required for the post and as may be specified by the State Government by notification.

Physical Measurement Test (PMT) The candidates being considered for recruitment as Inspector of Police (Armed Branch) in the West Bengal Police Force in the category of medal winner sports persons in select sports events/championships under special dispensation shall undergo Physical Measurement Test (PMT) which will be conducted by the West Bengal Police Recruitment Board and must meet the minimum physical standards as mentioned below subject to condition that physically disabled Persons are not entitled to be recruited in West Bengal Police Force due to service conditions they have to discharge:

- (2) No appeal shall lie against such order of discharge.

Seniority- The seniority of the officers in the post of Inspector of Police (Armed Branch) in the West Bengal Police Force recruited under these rules shall be on the basis of their dates of joining provided that in case of officers joining the post on the same date, the inter se seniority will be according to the dates of

(f) The candidate must meet the minimum physical measurement criteria as laid down in Rule 6.

7. **Verification of Character Antecedents**— All provisionally selected candidates shall be required to fill up a Verification Roll which shall be thoroughly enquired into by the concerned authority.

#### 8. Medical Examination—

All provisionally selected candidates shall required to appear for Medical Examination at the hospitals designated by the State Government for the purpose. The selected candidates should qualify the prescribed medical test. The candidate must not have knock knee, flat foot, varicose vein and squaint eyes. The minimum vision should be 6/6 with or without glasses. They should possess high colour vision and should not be colour blind. The medical tests shall also include the chest x-ray and other tests as prescribed by the Department of Health and Family Welfare, Government of West Bengal from time to time. The selected candidates should be in good mental and physical health and free from any physical deformity and disability likely to interfere with the training and efficient performance of the duties as police officer. The certificate of fitness shall be issued by the authorized medical officer

- **9. Appointing Authority**—Assistant Inspector General of Police or Superintendent of Police or Commandant, as the case may be will act as the Appointing Authority for the post of Assistant Sub-Inspector of Police (AB) in West Bengal Police Force under their rules.
- **10. Appointment, Training & Probation** (i) The candidates provisionally selected for appointment to the post of ASI(AB) shall after successful completion of verification of character and antecedents and medical examination, be appointed on temporary basis after successful completion of basic training they will be placed on probation for two years.
- (ii)They shall be required to undergo a prescribed course of training in accordance with the Police Regulations, Bengal and/or such rules and regulations as prescribed from time to time.
- ( iii) Upon completion of the period of probation they may be confirmed in service by the competent authority subject to their satisfactorily completing the course of training as well as passing the departmental examination as may be prescribed and also subject to their having the minimum educational qualification as provided in rule 5.

#### 11. Discharge-

(a) An Assistant Sub-Inspector of Police (AB) may, anytime during the period of probation or while undergoing training, be discharged simpliciter from service by the competent authority, without proceedings, if found unsuitable for the post.

The order of discharge shall include the grounds of discharge, but no formal proceeding shall be necessary. The order of discharge shall not be given effect to until its confirmation by the next higher authority.

(b) No appeal shall lie against the order of discharge.

#### 12. Seniority-

The seniority of the officers in the post of Assistant Sub-Inspector of Police (AB) in the West Bengal Police Force recruited under these rules shall be on the basis of their dates of joining provided that in case of officers joining the post on the same date, the inter se seniority will be according to the dates of winning the qualifying medal(s) and further that the dates of winning the qualifying medal(s) also being the same, the seniority of the officers will be according to the dates of birth, the officer having the earlier date of birth getting precedence in terms of seniority.

**13. Saving-** i) Nothing in these rules shall confer upon any person any right to be appointed as an Assistant Sub-Inspector of Police (AB) in the West Bengal Police Force in the category of medal winner sports persons under special dispensation and the State Government reserves the right to reject the candidature of any candidate or appoint him to a lower post without assigning any reason whatsoever.

ii) The medal winner sports persons in select sports events /championship who may have already been appointed before coming into force of these rules as ASI of Police (AB) in West Bengal Police Force under special dispensation in terms of the notification issued by the State government in this regard shall be deemed to have been appointed under these rules.

The instant departmental proceedings has been 'disposed of' by passing a final order on 06/02/2025 by the disciplinary authority with a punishment of withholding 01(one) increment for a period of 06(six) months without cumulative effect vide DO No. 208 dated 06/02/2025 of SRP, Howrah GRP. C/1698 Jitendra Kumar Singh is under currency of punishment at present.

Hence, considering the facts above, the Board unanimously decided to "Cancel" the promotion-cum-posting order in respect of C/1698 Jitendra Kumar Singh of Howrah GRP who was posted on promotion to SAP 13<sup>th</sup> Bn. and deputed to Howrah GRP vide memo no. 146(168)/CRO//CRO-81/2023 dated 05/03/2024 and declared him "Unfit" for promotion.

The sealed L-C-R-S sheets which was examined by the BOC(E&P) on 28/02/2024 is reopened and necessary noting has been incorporated in respect of C/1698 Jitendra Kumar Singh of Howrah GRP in view of this recent development (under currency of punishment) which has been signed by all members present in the BOC(E&P) including Chairman.

The matter should be incorporated in the service book of C/1698 Jitendra Kumar Singh of Howrah GRP.

- 4. Prayer of WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB regarding allowing CAS benefit who forgo his promotion to the rank of ASI(AB).
- SS (HQ), CID, WB vide memo no. 345/RO/CID dated 07/04/2025 was forwarded the petition dated 31/01/2025 submitted by WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB regarding reconsideration for entitlement to get CAS benefit and promotion to the rank of ASI(AB).
- > WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB was passed in the Departmental Examination for promotion to the rank of ASI(AB) in West Bengal Police-2023. Subsequently, he had submitted unwillingness to take promotion as ASI(AB). Accordingly, BOC(E&P) held on 07/02/2024, 08/02/2024 & 22/02/2024 unanimously decided to accept the unwillingness prayer of WC/T-229 Wadut Safeli Dakshin Dinajpur DD, CID, WB for promotion to the rank of ASI(AB). The Board also decided that in this case G.O. No. 9120-F dated 13/11/2000, of Finance Department Audit Branch, Govt. of West Bengal should be strictly followed and WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB will not be entitled to get any benefit under CAS, 1990. In this regard an order was done by CID, WB vide D.O. No. 850 dated 13/05/2024 in compliance of Org No. 107/CRO//CRO-01/2024 dated 06/05/2024.
- ➤ The matter is placed before BOC(E&P) for decision.

**DECISION:** The Board examined the relevant documents and it has been transpired that WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB has passed in the Departmental Examination for promotion to the rank of ASI(AB) in West Bengal Police-2023. But he was unwilling to take promotion and had forgone his promotion. Accordingly, BOC(E&P) held on 07/02/2024, 08/02/2024 & 22/02/2024 unanimously accepted the unwillingness prayer of WC/T-229 Wadut Safeli Dakshin Dinajpur DD, CID, WB for promotion to the rank of ASI(AB). The Board also decided that in this case, G.O. No. 9120-F dated 13/11/2000, of Finance Department Audit Branch, Govt. of West Bengal should be strictly followed and WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB will not be entitled to get any benefit under CAS, 1990. The matter was informed to SS(HQ), CID, WB vide Org No. 107/CRO//CRO-01/2024 dated 06/05/2024 and the same has been recorded in his service Book vide D.O. No. 850 dated 13/05/2024 of CID, WB.

The Board unanimously decided to uphold the decision of BOC(E&P) held on 07/02/2024, 08/02/2024 & 22/02/2024 which has already been communicated under Org No. 107/CRO//CRO-01/2024 dated 06/05/2024. Thus the petition dated 31/01/2025 of WC/T-229 Wadut Safeli of Dakshin Dinajpur DD, CID, WB received through SS (HQ), CID, WB vide memo no. 345/RO/CID dated 07/04/2025 is "disposed of".

Competent authority of CID, WB is also directed to strictly follow the directions given in Police Order No. 11 of 2024 in this regard.

### 5. Miscellaneous Correspondences:-

- A) To examine Length-cum-Record of Service of Constable-201 Debasis Nag of Photography Section, IB, WB for promotion to the rank of Assistant Sub-Inspector of Police, Photography Section, IB, WB.
  - > ADG, IB, WB has sent proposal under his office Memo No. 421/RO/CID dated 03/05/2025 for promotion of Constable-201 Debasis Nag of Photography Section, IB, WB in the rank of ASI(UB) in Photography Section of IB, WB against an existing vacancy of 01(one) ASI(UB) in Photography Section of IB, WB.
  - Range Board, comprising of Special Assistant to ADG & IGP, IB, WB; Special Superintendent of Police-(I), IB, WB and DIG, IB, WB was held on 22/04/2025 declared Constable-201 Debasis Nag of Photography Section, IB, WB "Fit" for promotion to the rank of ASI(UB) in Photography Section of IB, WB.
  - ➤ In terms of Regulation No. 741(E)(e) and Regulation No. 743(b)(i) of Police Regulation of Bengal, 1943 and G.O. No. 2936-PL/PI/8C-12/04(Pt-I) dated 24.07.2008 of Home Department Police Branch, Government of West Bengal, the Police personnel of photographic Bureau of CID, West Bengal and IB, West Bengal may be allowed for exemption to appear in the written test departmental examination to the next higher rank subject to the condition that they will not claim promotion to the next higher rank anywhere except in Photographic Bureau of CID, WB and IB, WB respectively.
- > There is 01(one) vacancy in the rank of ASI of Photography Section, IB, WB.

**DECISION:** The Board examined the L-C-R-S and approved the same for next course of action. Therefore, Constable-201 Debasis Nag of Photography Section, IB, WB is found to be provisionally "Fit" for promotion to the rank of ASI(UB) in the Photography Section of IB, WB. There are 01(one) vacancy in the rank of ASI of Police in Photography Section, IB, WB.

The Board Members opined that promotion order of Constable-201 Debasis Nag of Photography Section, IB, WB to the rank of ASI(UB) in the Photography Section of IB, WB may be

issued subject to the condition that he will not claim promotion to the next higher rank anywhere except in Photography Section of IB, WB in accordance with Regulation No. 743(b)(i) of Police Regulation of Bengal, 1943 read with G.O. No. 2936-PL/PI/8C-12/04(Pt-I) dated 24.07.2008 of Home Department Police Branch, Government of West Bengal.

# B) To examine Length-cum-Record of Service of 06(six) Watcher Constables of Photographic Bureau, CID, West Bengal for promotion to the rank of Assistant Sub-Inspector of Police, Photographic Bureau, CID, West Bengal.

- ➤ Range Board held on 25/04/2025 for promotion to the rank of ASI of Police in Photographic Bureau, CID, WB wherein, total 06(six) Watcher Constables of Photographic Bureau, CID, WB were declared provisionally "Fit" for promotion to the rank of ASI of Police in Photographic Bureau, CID, WB received under Memo No. 421/RO/CID dated 25/04/2025 of DIG (Special) CID, WB.
- ➤ In terms of Regulation No. 741(E)(e) and Regulation No. 743(b)(i) of Police Regulation of Bengal, 1943 and G.O. No. 2936-PL/PI/8C-12/04(Pt-I) dated 24.07.2008 of Home Department Police Branch, Government of West Bengal, the Police personnel of photographic Bureau of CID, West Bengal and IB, West Bengal may be allowed for exemption to appear in the written test departmental examination to the next higher rank subject to the condition that they will not claim promotion to the next higher rank anywhere except in Photographic Bureau of CID, WB and IB, WB respectively.
- ➤ The Range Board also declared that only 02(two) vacancies are available against the 02(two) sanctioned strength in the rank of ASI of Police in the Photographic Bureau, CID, WB.

**DECISION:** The Board unanimously decided to return the proposal. The CID should resubmit it after conducting Range Board amongst the eligible Constables posted in Photographic Bureau, CID, WB on permanent basis as per the existing Govt. Order.
