Police Order No. 06 of 2025 Date 16.06.2025

Subject:- Shifting of SAP 8<sup>th</sup> Bn. from Barrackpore to Suti PS area under Jangipur Police District (Murshidabad District).

After due consideration, it has been decided to shift the existing SAP 8<sup>th</sup> Battalion presently located at Barrackpore to Suti Police Station area under Jangipur Police District to cater the internal security infrastructure of Jangipur Police District as well as Murshidabad Police District and Malda District.

## Movement of Officer, Staff & Police Personnel, Vehicles and Arms & Ammunition etc. :

- A) The HQ Coy of SAP 8<sup>th</sup> Bn., including IHQ office, RO office, MT Section, Armoury Section, Clothing/Departmental Store, Band as may be moved to the new location at Ahiron Model School, Suti PS, Jangipur PD
- B) Rest Officer and force may be po9sted out to other battalions of Barrackjpore Brigade which have sufficient vacancy.
- C) The resultant vacancy of SAP 8<sup>th</sup> Bn. (to be shifted to Suti PS area in Jangipur PD) may be filled with the officers and force from other battalions of Barrackpore Brigade.

For effective function of the newly shifted SAP 8th battalion the following arrangements may be done:

#### 1. Supervision:

Commandant, SAP 9<sup>th</sup> Bn. may look after the works of Commandant, SAP 8<sup>th</sup> Bn. at Suti PS under Jangipur PD, Murshidabad District till a commandant is posted there. Existing ACs and Inspectors will be moved to the new location and additional officers may be posted on deputation as required.

### 2. Ministerial Staff:

The existing Ministerial Staff of SAP 8<sup>th</sup> Bn. may be retained and may be allowed to function at Barrackpore for the time being for preparation of bills etc. for the officers and force of the SAP 8<sup>th</sup> Bn. at Suti PS. Subsequently, Ministerial Staff from nearby areas will be posted at new location of SAP 8<sup>th</sup> Bn. Remaining Ministerial Staff of this battalion may be transferred to other battalions of Barrackpore Brigade in the existing vacancy.

### 3. Logistics:

### a) Vehicles:

The existing Vehicles of SAP 8<sup>th</sup> Bn. may be moved out to new location of SAP 8<sup>th</sup> Bn. at Suti PS, Jangipur PD.

#### b) Arms & Ammunition:

Existing stock of arms & ammunition (both lethal and non-lethal), of SAP 8<sup>th</sup> Bn. may be moved out to new location at Suti PS under Jangipur PD.

With reference to the earlier Notification No. 1180- I.S.S./2F-01/18 dated 09.09.2024 and in exercise of power conferred under Sub-Section(2) of Section 9 of the Manoeuvres, Field Firing and Artillery Practice Act, 1938 (Act 5 of 1938), the Governor is hereby pleased to re-notify the 100 meters Baffle Firing Range of 207 Cobra, P.S.-Salboni, District-Paschim Medinipur, having a total area of 141.24 acres within Plot nos. 1, 2, 3, 4, 5 (Part) and 5/204 in Mouza Dhengashole, J.L. No. 412, Khatian No. 1, as per the description mentioned in the Schedule to this Notification as an area within which field firing and artillery practice is authorized to carry out for a further period of 1 (one) year beyod 22.06.2025, i.e. with effect from 23.06.2025 to 22.06.2026, subject to fulfilment of strict precautionary measures and under prior intimation to all concerned, besides wide publicity, to avoid any untoward incident.

### THE SCHEDULE

The location of four directions of 100 meters Baffle Firing Range of 207 Cobra, P.S.-Salboni, District-Paschim Medinipur is described as:-

- 1) Eastern side: Land of South Eastern Railway & Railway track;
- 2) Western side: Land of Cobra up to 1500 feet distance;
- 3) Northern side: Land of Reserve Bank of India and Pacca Road;

2023-24.

Ref.: Your Letter Memo. No. IT/11/25-26 dated 19.05.2025, IT/11A/25-26 dated 22.05.2025 &

IT/11/3/25026 dated 04.06.2025 and this office vide Memo. No. 650/HA, dated 02.06.2025.

With reference to your letter on the subject quoted above, following are mentioned:-

- i) You have offered the tender against NIT No. WBP/COSAP3rdBNBKP/NIT-01.2024-25 dated 19.07.2024 floated by CO, SAP 3<sup>rd</sup> Bn., Barrackpore, West Bengal for various items including the "Napthalene 200 gm. Packet".
- ii) You have technically qualified and ranked as LI bidder for the item quoting lowest rate i.e. Rs. 1,47,000/- (Rupees One Lakh Forty Seven Thousand) only including GST and all other taxes for 1,500 Kgs. of Napthalene 200 gm Packet.
- iii) The sample of the item i.e. "Napthalene 200 gm. Packet" supplied by you as per this specifications have been accepted by the Central Clothing Committee.
- iv) In connection with this a letter for agreement for supply of 1,500 kgs. of "Napthalene 200 gm. Packet" was issued by CO, SAP 3<sup>rd</sup> Bn., Barrackpore (vide Memo. No. 550/HA dated 13.05.2025).
- v) After that a letter was received from your end vide reference no. IT/11/25-26 dated 19.05.2025 wherein you have stated that the quotation made by you was done mistakenly as you have quoted the rate for the said item for 200gm instead of per kilogram. This mistake lead to a quotation of Rs. 1,47,000/- (Rupees one lakh forty seven thousand) instead of Rs. 7,35,000/- (Rupees seven lakh thirty five thousand).
- vi) Then another letter was received from your end vide IT/11A/25-26 dated 22.05.2025 stating that after consideration you are voluntarily offering a discount of Rs. 18/- per 200 gm Pack, thereby reducing the rate to Rs. 80/- per pack, which translate to Rs. 400/- per kg., bringing the total to Rs. 6,00,000/- (Rupees six lakh) for 1,500 kgs. of "Napthalene 200 gm. Packet"
- vii) Your prayer ref. no. IT/11/25-26 dated 19.05.2025 and IT/11A/25-26 dated 22.05.2025 were placed before Tender Floating Authority and rejected by them.
- viii) Your failure to supply the item "Napthalene 200 gm. Packet" after acceptance of the rate offered by you and not to execute agreement of contract, not only violate the terms and condition of the tender notice but also dislocation in smooth supply of the said essential item to West Bengal Police and considerable financial loss to Government.
- You have violated the terms and condition of the tender notice where in you have quoted the price Rs. 1,47,000/(Rupees one lakh forty seven thousand) to the said item. The failure to supply the said item will also affect the annual budget of the West Bengal Police. More so, the department cannot meet the requirement in times.
- x) A show-cause letter was issued to you under this office Memo. no. 650/HA dated 02.06.2025 asking explanation for such lapses committed by you within 15 (fifteen) days and also to let this office know why your firm will not be blacklisted as per terms & conditions laid down in the NIT.
- xi) In reply to the show-cause notice, the explanation given by you vide your letter no. IT/11/3/25-26 dated 04.06.2025 was placed before committee and was found not satisfactory and convincing as per terms of tenders prescribed by the Finance Department.

In view of the above facts and prejudice, EMD submitted by you is forfeited and your firm is hereby blacklisted for a period of 01 (one) years from date of issue of this letter rnad the order placed vide this office Memo. No. 550/HA dated 13.05.2025 are hereby cancelled.

AND WHEREAS on recommendation of the Commission and in the public interest, the Government of West Bengal has published a Notification vide No. 917-BCW/MR-33/2025 dated the 8<sup>th</sup> May, 2025 sub-categorising the backward classes in the State List of Other Backward Classes in to two sub-categories being 'Category –A' and 'Category-B' wherein Category-A classes would mean "More Backward" and Category-B classes would mean 'Backward' within the "backward classes";

#### **NOTIFICATION**

No. 1106-BCW/MR-33/2025 dated the 3<sup>rd</sup> June, 2025 – WHEREAS "backward classes" have been defined in clause (a) of section 2 of the West Bengal Commission for Backward Classes Act, 1993 (West Ben. Act I of 1993) (hereinafter referred to as the said Act), for the purposes of the said Act, to mean such backward classes of citizens other than the Scheduled Castes and the Scheduled Tribes as may be specified by the State Government in the lists.

AND WHEREAS "lists" have been defined in clause © of section 2 of the said Act to mean lists prepared by the Government of West Bengal from time to time for the purposes of making provision for the reservation of appointments or posts in favour of backward classes of citizens which, in the opinion of that Government, are not adequately represented in the services under the Government of West Bengal, and any local or other statutory authority within the territory of West Bengal or under the control of the Government of West Bengal.

AND WHEREAS the West Bengal Commission for Backward Classes ("Commission") was set up under section 3 of the said Act for identification of these Other Backward Classes of this State.

AND WHEREAS in terms of clause (b) of sub-section (1) of section 9 of the said Act, the advice of the Commission shall ordinarily be binding upon the State Government;

AND WHEREAS on recommendation of the Commission and in the public interest, the Government of West Bengal has published a Notification vide No. 917-BCW/MR-33/2025 dated the 8<sup>th</sup> May, 2025 sub-categorising the backward classes in the State List of Other Backward Classes under the provisions of the said act into two sub-categories being 'Category –A' and 'Category-B' wherein Category-A classes would mean "More Backward" and Category-B classes would mean 'Backward' within the "backward classes";

AND WHEREAS on recommendation of the Commission, 64 classes enlisted in the State list of OBCs prior to 2010, have been sub-categorised as 14 classes under Category-A and 50 classes under Category-B vide Notification No. 1056-BCW/MR-33/2025(Pt. I) dated the 27<sup>th</sup> May, 2025.

AND WHEREAS on recommendation of the Commission, 51 classes have been included in the State list of OBCs vide Notification No. 1057-BCW/MR-38/2025 dated the 27<sup>th</sup> May, 2025, out of which 27 classes has been placed under Category-A and 24 classes under Category-B;

AND WHEREAS, at present there are 115 numbers of classes in the State List of OBCs out of which 41 classes have been sub-categorised under Category-A and 74 classes under Category-B;

AND WHEREAS by this Department Order No. 1056-BCW/EC/MR-302/97 dated the 6<sup>th</sup> November, 1997 provision was made for the 7% reservation in services and posts under the Government of West Bengal, the local and statutory authorities constituted under any Stat Act, corporations in which not less than 51% of the paid up share capital is held by the State Government, Universities, Colleges affiliated to Universities, primary, secondary and higher secondary schools, other educational instutitions which are owned or aided by the State Government and public sector in favour of Backward Classes of citizens as specified in the list;

AND WHEREAS the State Government requested the Commission for consultation on determination of percentage of reservation for backward classes of citizens for their adequate representation in the services under the Government of West Bengal;

AND WHEREAS the Commission, after carefully examination of all facts, cricumstances and date, recommended to the State Government that the percentage of reservation for Backward Classes may be increased by another 10% thereby increasing the percentage of such reservation of vacancies in services and posts to 17% and also that 10% and 7% of separate quota of reservation may be provided for the Category-A and the Category-B of the Other Backward Classes respectively;

Now, THEREFORE, in consideration of the recommendation of the Commission and in the public interest, in pursuance of the provisions of clause (c) of section 2 and clause (b) of sub-section (1) of section 9 of the West Bengal Commission for Backward Classes Act, 1993 (West Bengal Act I of 1993), the Governor is pleased hereby to increase the percentage of reservation for Other Backward Classes in West Bengal to 17% providing 10% reservation for Category-A and 7% for Category-B respectively.

No. 1056-BCW/MR-33/2025 dated the 27<sup>th</sup> May, 2025 – WHEREAS "backward classes" have been defined in clause (a) of section 2 of the West Bengal Commission for Backward Classes Act, 1993 (West Ben. Act I of 1993) (hereinafter referred to as the said Act), for the purposes of the said Act, to mean such backward classes of citizens other than the Scheduled Castes and the Scheduled Tribes as may be specified by the State Government in the lists.

AND WHEREAS "lists" have been defined in clause © of section 2 of the said Act to mean lists prepared by the Government of West Bengal from time to time for the purposes of making provisions for the reservation of appointments or posts in favour of backward classes of citizens which, in the opinion of that Government, are not adequately represented in the services under the Government of West Bengal, and any local and statutory authority within the territory of West Bengal or under the control of the Government of West Bengal.

AND WHEREAS the West Bengal Commission for Backward Classes ("Commission") was set up under section 3 of the said Act for identification of these Other Backward Classes of this State.

AND WHEREAS in terms of section 9 of the said Act, the Commission considers inclusion, over-inclusion, or under-inclusion of any such Other Backward Class and tenders such advice to the State Government as it deems appropriate and such advice of the Commission being ordinarily binding upon the State Government.

AND WHEREAS on recommendation of the Commission and in the public interest, the Government of West Bengal has published a Notification vide No. 917-BCW/MR-33/2025 dated the 8<sup>th</sup> May, 2025 sub-categorising the backward classes in the State List of Other Backward Classes into two sub-categories being 'Category –A' and 'Category-B' wherein Category-A classes would mean "More Backward" and Category-B classes would mean 'Backward' within the "backward classes";

AND WHEREAS the Commission had decided to conduct a Banchmark Survey through the Bureau of Applied Economics and Statistics and Cultural Research Institute covering the existing 66 classes enlisted in the State List of Other Backward Classes prior to 2010 to determine their degree of backwardness;

AND WHEREAS pursuant to the receipt of the report of the survey on the said 66 classes, the commission has, based on detail surveys, and a comprehensive consideration of all relevant material and data, formed a reasoned opinion and recommended to the State Government to sub-categorise 64 classes out of the said 66 classes into Category-A and Category-B depending on their relative backwardness;

Now, THEREFORE, in consideration of the recommendation of the Commission and in the public interest and in pursuance of the provisions of clause (c) of section 2, sub-section (1) of section 09 and sub-section (1) of section 11 of the said Act a d in continuation of Notification No. 917-BCW/MR-33/2025 dated the 8<sup>th</sup> May, 2025, the Governor is pleased hereby to sub-categorise 64 classes out of the 66 classes in the lists of backward classes notified for the purpose of the said Act priror to the year 2010 into two categories as 'Category-A' and 'Category-B', wherein the Category-A would mean the 'More Backward' and the Category-B would mean the "Backward" within the 'backward classes' in the following manner:-

AND WHEREAS the West Bengal Commission for Backward Classes ("Commission") was set up under section 3 of the said Act for identification of these Other Backward Classes of this State.

AND WHEREAS in terms of section 9 of the said Act, the Commission considers inclusion, over-inclusion of under-inclusion of any such Other Backward Class and tenders such advice to the State Government as it deems appropriate and such ad vice of the Commission being ordinarily binding upon the State Government;

AND WHEREAS the Hon'ble Division Bench of High Court at Calcutta by judgement and order dated the 22<sup>nd</sup> May, 2024 in WPO 60 of 2011 and other connected matters (Amal Chandra Das & Ors. vs State of West Bengal & Ors.) set aside executive order No. 6309-BCW/MR-84/10 dated the 24<sup>th</sup> September, 2010, previously issued by the Government of West Bengal, sub-categorising the then enlisted classes in the State List of Other Backward Classes into "Category A" and "Category B" for the reasons contained therein and held that sub-categorisation of the relevant classes may be done by the Government only in consultation with the Commission.

AND WHEREAS a Special Leave Petition has been preferred by the State of West Bengal being SLP $^{\odot}$  No. 017751-017755/2024 (State of West Bengal vs Amal Chandra Das & Ors.) from the said judgement and order dated the  $22^{nd}$  May, 2024 of the Hon'ble High Court at Calcutta which is pending before the Hon'ble Supreme Court of India;

AND WHEREAS the West Bengal Commission for Backward Classes has commenced the process of conducting a fresh Benchmark Survey to ascertain the backwardness of the various classes who had applied afresh for inclusion into the State List for Other Backward Classes strtictly without prejudice to the rights and contentions of the Commission in the aforesaid pending SLPs before the Hon'ble Apex Court;

AND WHEREAS the Hon'ble Supreme Court in its order dated the 18<sup>th</sup> March, 2025 has also recorded the fact of new exercise of examining the issue of backward classes afresh and fixed the appeals for learning in the month of July, 2025.

AND WHEREAS the Government consulted the Commission in its 462<sup>nd</sup> Meeting held on 29<sup>th</sup> April, 2025 and the Commission for the several reasons contained in the said minutes of its meeting, has recommended to the State Government that the Other Backward

Classes in the State may be sub-categorised into two categories being the "More Backward (Category A) and "Backward (Category B", to be based upon the Benchmark Score obntained by the several classes in the respective benchmark survey;

AND WHEREAS the Government of West Bengal on the basis of consultation held and the recommendation provided by the Commission, has decided to sub-categorise the backward classes in the State List into two sub-categories as "More Backward (Category-A)" and "Backward (Category B)";

Now, THEREFORE, in consideration of the recommendation of the Commission and in the public interest, the Governor is pleased hereby to sub-categorise the backward classes in the State List of Other Backward Classes for the prupose of the said Act into sub-categorises being 'Category-A' and 'Category B', wherein Category-A classes would mean 'More Backward' and Category-B classes would mean 'Backward' within the "backward classes".
