MINUTES OF THE MEETING OF THE BOARD OF CONTROL FOR EXAMINATION AND PROMOTION HELD ON 17/07/2025

A meeting of the Board of Control for Examination and Promotion was held on 17/07/2025 at 17:00 hrs. in the DGP'S Conference Hall, at Bhabani Bhaban, Kolkata-27.

Shri Vineet Kumar Goyal, IPS, Additional Director General & Inspector General of Police (Administration), West Bengal, Chairman of the Board presided over the meeting.

The following members of the Board attended the meeting:-

- 1. Shri Rishikesh Meena, IPS, Inspector General of Police, Organisation, West Bengal.
- 2. Shri Arindam Dutta Chowdhury, IPS, Deputy Inspector General of Police (Administration), West Bengal.
- 3. Shri Joy Biswas, IPS, IPS, Deputy Inspector General, Provisioning, WB and holding addl. charge of DIG (Planning & Welfare), West Bengal.
- 4. Shri Amit Kumar Singh, IPS, Vice Principal, SVSPA, Barrackpore in the rank of DIG. -Coopted Member.
- 5. Shri Dipanjan De, Sr. Deputy Secretary to the Govt. of West Bengal, Home and Hill Affairs Department.

The following points were discussed in the meeting of BOC for Examination & Promotion.

- 1. To examine and approve Result of the Final Examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT) of Batch No. 02/2025.
 - ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(MT)/07(II)/2025-1645 dated 13/06/2025, containing the result of the Final Examination of Post-Promotional Training Course for confirmation to the rank of ASI(MT) of Batch No. 02/2025 which commenced on and from 21/04/2025 and ended on 30/05/2025 vide Police West Bengal Org No. 89-CRO//CRO-07/2025 dated 28/03/2025.
 - ➤ Total 99(ninety nine) candidates reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. Thus, 99 trainees appeared in the final examination in all subjects but out of them 01(one) ASI(MT) did not qualify in Paper-II & Drill outdoor subject and remaining 98 candidates qualified successfully.
 - > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.
 - **DECISION:** The Board examined the result and approved the same for next course of action. Total 98(ninety eight) trainees have been qualified the Post-Promotional Training Course for confirmation to the rank of ASI(MT).

One (01) candidate namely ASI(MT)-454 Anil Kumar Singh of Sundarban PD (Sl. no. 97 of the result sheet) did not qualify in Paper-II & Drill outdoor subject of the examination.

IGP, SVSPA, WB will ask SP, Sundarban PD well in advance to direct ASI(MT)-454 Anil Kumar Singh of Sundarban PD to appear in Paper-II & Drill outdoor subject in the next supplementary examination.

- 2. To examine and approve Result of the Final Examination of Pre/Post-Promotional Training Course of ASI(UB) for Promotion / confirmation to the rank of SI(UB) of Batch No. 39/2025 and Supplementary examination of PPT Course of ASI(UB) for promotion to the rank of SI(UB) of Batch No. 37/2025.
 - ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(UB)/03(XXIII)/2018-1764 dated 26/06/2025, containing the result of the final examination of Pre/Post-Promotional Training Course of ASI(UB) for Promotion / confirmation to the rank of SI(UB) of Batch No. 39/2025 and Supplementary examination of PPT Course of ASI(UB) for promotion to the rank of SI(UB) of Batch No.

37/2025 which commenced on and from 05/05/2025 and ended on 04/06/2025 vide Police West Bengal Org No. 14-CRO//CRO-104/2024 dated 13/01/2025 and Org No. 137-CRO//CRO-104/2024 dated 29/04/2025.

- ➤ Total 115(one hundred fifteen) candidates reported at SVSPA, WB, Barrackpore to undergo the aforesaid training course. They completed the training and appeared in the Final Examination in all subjects and qualified successfully.
- ➤ On the other hand, 01 ASI(UB) of Murshidabad PD of PPT Batch No. 37/2025 was not qualified in Paper-III and did not appear in Paper-II in Indoor Subjects in the Final Examination. So, he appeared in the supplementary Examination in Paper-III & Paper-II and qualified successfully.
- The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

<u>DECISION:</u> The Board examined the result and approved the same for next course of action. Total 115(one hundred fifteen) trainees have been qualified the Pre/Post-Promotional training for promotion / confirmation to the rank of SI(UB).

One (01) ASI(UB)-1621 Abul Basar Ali of Murshidabad PD of PPT Batch No. 37/2025 who was not qualified in Paper-III and did not appear in Paper-II in Indoor Subjects in the Final Examination, has appeared in the supplementary Examination in Paper-III & Paper-II and qualified successfully.

- 3. To examine and approve Result of the Final Examination of Pre/Post-Promotional Training Course of ASI(AB) for Promotion to the rank of SI(AB) of Batch No. 31/2025 and Supplementary examination of PPT Course of ASI(AB) for promotion to the rank of SI(AB) of Batch No. 29/2024.
 - ➤ IGP, SVSPA, WB, Barrackpore has sent memo no. SVSPA/Exam.Cell/PPT/ASI(AB)/04(XVII)/2018-1765 dated 26/06/2025, containing the result of the final Examination of Pre/Post-Promotional Training Course of ASI(AB) for Promotion to the rank of SI(AB) of Batch No. 31/2025 and Supplementary examination of PPT Course of ASI(AB) for promotion to the rank of SI(AB) of Batch No. 29/2024 which commenced on and from 05/05/2025 and ended on 04/06/2025 vide Police West Bengal Org No. 138-CRO//CRO-105/2024 dated 29/04/2025 and Police West Bengal Org No. 305-CRO//CRO-105/2024 dated 05/11/2024.
 - ➤ Total 180(one hundred eighty) ASI(AB) [out of this 44 candidates reported at SVSPA, WB, Barrackpore and 136(one hundred thirty six) candidates reported at STC, SAP 1st Bn.] went to undergo the aforesaid training. Out of them 01(one) candidate, who reported at STC, SAP 1st Bn., did not appear in the indoor examination due to his cardiac illness. Remaining 179(one hundred and seventy nine) candidates appeared in the final examination and qualified successfully.
 - > On the other hand out of 09(nine) ASI(AB) of different units who were not qualified in the Weaponry of Outdoor subjects in the final examination of PPT Batch No. 29/2024, 01(one) ASI(AB) has already expired and 01(one) ASI(AB) is retired on superannuation. The remaining 07(seven) ASI(AB) appeared in the supplementary examination and qualified successfully.
 - > The results of the same were placed before the 'Board of control for Examination and Promotion' for perusal and approval.

<u>DECISION:</u> The Board examined the result and approved the same for next course of action.

Total 179(one hundred and seventy nine) trainees have been qualified in the Final Examination of Pre/Post-Promotional Training Course for Promotion to the rank of SI(AB).

One(01) ASI(AB)-670 Sumanta Biswas of ADPC of PPT Batch No. 31/2025 did not appear in the final examination.

CP, ADPC will ensure that, ASI(AB)-670 Sumanta Biswas of ADPC who did not appear in the final examination of PPT, should undergo the PPT in the next Batch.

Nine (09) ASI(AB) of different units were not qualified in the Weaponry of Outdoor subjects in the final examination of PPT Batch No. 29/2024. Out of them, 01(one) ASI(AB) has already expired and 01(one) ASI(AB) is retired on superannuation. The remaining 07(seven) ASI(AB) appeared in the supplementary examination and qualified successfully.

- 4. To examine Length-Cum-Record of Service of 33 (thirty three) Supervisor (Technical) Grade-II for promotion to the rank of Supervisor (Technical) Grade-I, in West Bengal Police Telecommunication Branch.
 - ➤ DG & IGP, Telecommunication, WB vide his Memo No. 1542/P dated 18.06.2025 has sent a letter enclosing the Minutes of the meeting of WBP Telecommunication Range Board held on 18.06.2025 and Broad Sheet containing of 33 (thirty three) willing and 07(seven) unwilling candidates for promotion from Supervisor (Technical) Grade-II to the rank of Supervisor (Technical) Grade-I in West Bengal Police Telecommunication Branch.
 - ➤ The Range Board declared that 33(thirty three) willing Supervisor (Technical) Grade–II are provisionally "Fit" for promotion to the next higher rank and 07(seven) Supervisor (Technical) Grade–II submitted their unwillingness for promotion to the next higher rank.
 - At present, there are 07(seven) vacancies in the rank of Supervisor (Technical) Grade-I in West Bengal Police Telecommunication Branch. It has also been stated that, according to 50-Point Roster of Supervisor(Technical) Grade-I the last vacancy i.e. 44th was filled up during the last round of Promotion order issued and the vacancy will be filled up from 45th Point of 3rd circle of 50-Point Roster to next 01 point of 4th circle of 50-Point Roster of Supervisor(Technical) Grade-I.
 - ➤ The L-C-R-S has been placed before the 'Board of control for Examination and Promotion' for perusal and approval.

DECISION: The Board examined and approved the L-C-R-S of 33(thirty three) willing Supervisor (Technical) Grade-II and 07(seven) unwilling Supervisor (Technical) Grade-II for promotion to their next higher rank received under Memo No. 1542/P dated 18.06.2025 of DGP, Telecommunication, West Bengal.

However, during scrutiny the following discrepancies have been found:-

- i. In respect of SR(T)II Bimal Kumar Pal (Sl. No. 27), the date of promotion as SR(T)II is mentioned as 19/07/2018 in the Broad Sheet, whereas, as per the Service Book, the correct date is 16/07/2018.
- **ii.** In respect of SR(T)II Tapas Kumar Dey (Sl. No. 22), the total marks obtained in ACR (01/04/2020 to 31/12/2024) in the Broad Sheet is shown as 231.69, whereas, as per the ACR calculation sheet, the candidate has actually obtained 228.69 marks.

The members of Range Board for promotion of Supervisor (Technical) Grade–II should rectify the anomalies before accordance of promotion. The promotion of the Supervisor (Technical) Grade–II to the rank of Supervisor(Technical) Grade-I may be accorded observing all formalities, maintaining the inter-se-seniority of the candidates as per West Bengal Services (Determination of Seniority) Rules, 1981 and existing rules of 50-Point Roster amongst the "fit' candidates as per available vacancy for the post of Supervisor (Technical) Grade–I.

Promotion of 33 Supervisor (Technical) Grade–II to their next higher rank will be carried out in phases, subject to availability of vacancy and in accordance with existing rules and procedures.

The Competent Authority of Telecommunication, West Bengal shall accord promotion of Supervisor (Technical) Grade–II to Supervisor (Technical) Grade–I upon successful completion of a 02(two) weeks refresher course at the Telecommunication Branch, WBP.

The training syllabus will be designed by Telecommunication, WB in consultation with IGP, SVSPA, Barrackpore, and submit to BOC (Training) for approval. Such process should be completed within 02(two) months.
